Item 279 RESIDENTIAL ADDITIONAL LINE BUNDLE (Discontinued effective May 30, 2008, pursuant to Telecom Order CRTC 2008-146.)^{§1}

A. GENERAL

1. The Residential Additional Line Bundle provides loyal BC TEL residential customers with a package of services at a single monthly rate. The package consists of: (i) one (1) additional individual residential access line, including the Company's Message Relay Centre (MRC) charge; (ii) a choice of one (1) SmartTouch or Integrated Voice Messaging Service (IVMS) from Item 143 or Item 168-A respectively with certain exceptions as noted in 2. below; iii) 120 hours per month of internet service; and iv) one (1) e-mail address in addition to the address included with internet service.
2. The customer may select any SmartTouch Service specified in Item 143, or IVMS specified in Item 168-A with the exception of: Call Forwarding-Fixed Central Office, Call Answer Plus Voice Mailbox, Silver Voice Mailbox, Family/Extension Option, Message Monitor and Paging Outcall or any features only available on a pay-per-use basis. (Note 1)
3. The additional access line included in this package must be an additional access line under the same customer name and at the same service address as the subscribing customer's primary access line.
4. Except as modified herein, the residential additional access line is provisioned according to the terms and conditions contained in CRTC 1005, Section II, Exchange Classification and Rates.
5. Except as modified herein, the SmartTouch Service or IVMS selected is provisioned subject to the terms and conditions contained in Items 143 and 168-A respectively and is only available on the additional access line included in this service.
6. Additional hours of internet service usage outside of the 120 hours provided in this package are not available through the Company.
7. In order to be eligible for this offer, the customer must have the Company as their Primary Interexchange Carrier (PIC) for their long distance services on their primary line, as well as on the additional line included in this package.

C. TERMS AND CONDITIONS

1. Customers must subscribe to the offer to be eligible.
2. Customers may cancel their subscription to the offer at any time without penalty by contacting the Company. Charges billed in advance will be prorated to reflect the date of cancellation and a credit will be applied to the customer's bill as appropriate.
3. Customers are not required to subscribe to all components of the package, however, the full package price will apply.
4. A customer may substitute one SmartTouch or IVMS feature for another, or add an eligible feature if they have not selected a SmartTouch or IVMS feature, following their initial subscription to the offer, but applicable service charges will apply. For customers who substitute or select Call Answer as their package feature following their initial subscription, service charges will be waived.
5. Customers moving to a different exchange may also change their choice of SmartTouch service or IVMS if their original choice is not available in the new exchange without incurring additional charges.
6. This service package is only available where facilities exist to provision additional residential access lines. All other components of the package are also subject to availability.
7. Customers subscribing to the Residential Additional Line Bundle must have the Company as their PIC on the additional line at time of billing in order to be eligible for the rates, terms and conditions of this service.
