680 TCI Centrex Contract Signing Bonus Promotion

ITEM
680.1 Service Description

The TCI Centrex Contract Signing Bonus Promotion (the "Promotion") is a limited time offer to existing TCI Centrex Customers subscribing to Centrex service under the former TELUS Communications Inc.'s Competitive Terminal Services Tariff Item 2260 whose commitment is 10,0001 or more Centrex access lines. The Promotion proposes to offer an incentive to qualifying Centrex Customers to renew their Centrex contract commitments for either 3 years or 5 years, upon which they will receive credits on their bill in accordance with Item 680.3. The credit amount shall be equal to that reflected on the Customer's Centrex Service bill for contracted Centrex lines for the month in which the credit is applied. Credit amounts will depend on the length of the contract commitment.

ITEM 680.2 **Conditions of Service**

- The Promotion is only available to existing TCI Centrex Service Customers currently subscribing to the former TELUS Communications Inc.'s Competitive Terminal Services Tariff, Item 2260, who sign a new Centrex service agreement for a three or five year term. Customers may take advantage of this Promotion only once per contract during the Promotion period.
- Termination liability shall not be assessed where Customers with time remaining on their current Centrex contract choose to sign a new contract for a longer term than the time remaining on their existing contract for at least the same number of lines as on the existing contract.
- 3. Customers wishing to take advantage of this Promotion must sign an agreement that extends their current contract end date by at least six months.
- 4. The Promotion offers each eligible Customer credits on their bill, equal to their Centrex Service bill for Centrex lines under contract, for the month in which the credit is applied, based on the following new contract sizes and terms. Lines not under contract but belonging to a Customer for whom a contract signing bonus is being applied are not eligible.
- 5. The promotion will commence 1999 12 09 with an end date of 2000 03 31.
