    - e) Receive Charges

The provision of satellite signal reception facilities is charged for at \$100.00 per hour per location.

- C. SERVICE CHARGES
  - 1. The service charge for Transmission is \$100.00 per transmit period up to \$500.00 per location per month and applies to each simultaneous transmission from the same location. This charge is not applicable when customer-provided uplink facilities are used.
  - 2. The service charge for Reception is \$50.00 per receive period up to \$250.00 per location per month.
- D. CONDITIONS
  - 1. The rate for a ten (10) minute interval or fraction is calculated at one sixth (1/6) of the applicable hourly rate.
  - 2. The minimum service period per occasion is one-half (1/2) hour for PT or NPT and one (1) hour for NOT.
  - 3. The cost of any service or part, scheduled and subsequently cancelled by the customer within 24 hours of the scheduled time, shall be charged to the customer unless the satellite provider is able to re-schedule the period in question.
