ITEM

580.1 Service Description

Wireless Payphone Service ("WPS") primarily involves the provision of outgoing message service from a wireless network and telephone equipment supplied by TCI for use by the general public. The Customer pays for the message using an authorized payment method in an appropriately equipped public telephone. WPS authorized payment methods for outgoing messages include prepaid cash card, billed to a calling card, billed to a commercial credit card, billed to third number or billed as a collect call.

580.2 **Conditions of Service**

- 1. WPS shall be provided on the C800 Analog Cellular Network.
- 2. WPS equipment will be provided by TCI. Inside wiring may be provided by TCI at TCI's expense on public or private property in locations approved by TCI.
- 3. To avoid any interruption of WPS to the general public, regardless of whether TCI or the owner of private property owns the inside wiring, the owner of private property shall permit TCI to perform all maintenance of the inside wiring at TCI's expense.
- 4. When WPS equipment is located on private property, TCI will negotiate with the owner of private property a reasonable amount of compensation for the space and facilities required for TCI to provide, install and maintain its equipment.
- 5. Extension Service will not be provided with WPS.
- 6. TCI shall deny the termination or completion of all incoming telephone calls placed to WPS equipment, except in those circumstances where TCI decides or mutually agrees with the owner of the private property on which the WPS is located that incoming telephone calls are of benefit to the user of the WPS.
- 7. Messages, whether terminating within or outside the local calling area, may be paid for at the time they are to be sent by using an authorized payment method in an appropriately equipped public telephone. TCI shall determine those public telephones which are used to provide these transactions.
- 8. WPS will be offered at exchanges where the necessary cellular switching equipment and facilities are available.

- 9. WPS will be offered at locations where adequate cellular signal and voice channel capacity is available.
- 10. WPS will be limited to the capabilities of the Company's cellular switch and switching translations.
- 11. Calls terminating outside Canada and continental USA (including Hawaii) will be denied.

580.3 **Rates**

The Customer shall pay to TCI the following rates and charges for WPS.

- Note 2: Rate includes a blended charge of airtime and long distance.
- **Note 3**: If the WPS installation is within a local Exchange Service area, existing Public or Semi-Public Telephone Service tariff rates apply for local and toll-free telephone Calls.
- **Note 4:** Toll-free service airtime to be paid via authorized prepaid cash card only.
