Dear Daniel:

Please refer to the Lease Agreement entered into between Standard Life Assurance Company, now The Standard Life Assurance Company of Canada ("Owner") and TELUS Communications (QUEBEC) Inc. now TELUS Communications Company ("Lessee") with a Lease term commencing May 1, 2001 for space occupied to provide telecommunications services in the building bearing a civic address of 666 St-Martin Blvd. W., Laval, Québec ("Building"), which Agreement expired at the end of April, 2012 following the first renewal period.

We continue to provide service in the building as stipulated by the Canadian Radio-television and Telecommunications Commission under Decision 2003-45. We hereby provide notice to extend the Term of the Agreement for a further period of Five (5) years commencing May 1, 2012 ("Commencement Date") and expiring on April 30, 2017 ("Termination Date") under the same terms and conditions existing during the last twelve months of the Licensee Term except a market rental rate of Three Thousand, Two Hundred DOLLARS (\$3,200.00) gross, per annum, plus taxes.


