ITEM 628 Data Transmission – Multi-point Anti-streaming Service (MASS) (B.C. Only)

ITEM

628.1 Service Description

Provides private line data customers with the capability of isolating terminal malfunctions from the rest of the circuit.

MASS may be used in conjunction with Analogue Private Line Services (General Tariff CRTC 21461, Item 522) in British Columbia.

ITEM

628.2 **Conditions of Service**

- 1. Service Contract Period: 2003 05 29 to 2008 05 31.
- 2. A minimum average monthly base of 3,500 MASS Drops will be maintained for the first year of the contract, 2,500 MASS Drops for the second year and 2,000 MASS Drops for the third and fourth years.
- 3. Notwithstanding Item 628.2.2, if:
 - a) the Customer has contracted with the Company or a Company affiliate for service or services to replace those offered pursuant to this Tariff Item;
 - b) the Customer seeks to migrate to the new services referenced in Item 628.2.3.a; and
 - c) the committed revenues under the new contract are equal or greater than those remaining under the original contract for the service in this Tariff Item; then
 - d) the minimum average monthly base will not be applied during the migration period.
- 4. For purposes of Item 628.2.3, the "migration period" commences on January 1, 2007, and ends on May 31, 2008.
- 5. Network Anti-streaming will be provided subject to the availability of suitable facilities and sufficient capacity.
- 6. If the Customer terminates this Special Assembly prior to the expiry of the contract term, the Customer shall pay to the Company all outstanding charges up to the effective date of termination plus the present worth of the remaining monthly charges for the unexpired portion of the contract term as calculated by the Company.
- 7. Termination charges will be waived if the customer contracts for another service from the Company or its affiliate where the committed revenues under the new contract are equal to or greater than those remaining under the original contract.
