## Item 133 SPACETEL SERVICE (Note 1)

A. DESCRIPTION OF SERVICE

Spacetel Service is a communications network that is provided to the customer under the following network configurations.

<u>Option (1)</u> - Spacetel Star Network - consists of an earth station (remote terminal) at the customer's location, access to a transponder segment on an Anik Satellite, a master control station located in Vancouver and connection to the exchange network at Vancouver.

 $\underline{Option}$  (2) - Spacetel Point-to-Point Network - consists of earth stations (remote terminals) at two or more of the customer's locations and access to a transponder segment on an Anik Satellite.

- The Spacetel Star Network provides both Spacetime Per Minute and Full Time Space Segment Usage, however, only one type of usage, that is, either Per Minute or Full Time service shall be provided on all channels of any one system.
- 3. Vancouver is the rate center for all calls between the Spacetel remote terminal and points outside of the Vancouver Extended Area Service. The Company is applicable non- C tariffed long distance message toll service rates and charges shall apply in addition | to the Space Segment Usage.
- 4. Per minute Spacetime rates are charged to the Spacetel customer on all incoming and outgoing calls (except for outgoing Personal Calling Option calls).
- 5. The chargeable time begins when communication is established between the Spacetel remote terminal and the calling or called telephone or facility and ends when the connection is terminated.
- 6. Calls originating from a Spacetel remote terminal that does not receive reverse battery answer supervision will have a 'set-up' time factor deducted from the message timing in order to determine the chargeable time.
- 7. Message billing is based on the accumulated time for all calls placed to or from the Spacetel SCRT/MCRT during a one month period.
- 8. The minimum monthly billing applies on a per channel basis for all types of Spacetime usage excluding Personal Calling usage. Additionally, only one minimum monthly billing per channel will apply to an alternate voice/data channel.
- 9. For 2 or more channels on the same multi-channel remote terminal, the Spacetime billing is the minimum billing per channel multiplied by the number of channels or the total aggregate Spacetime billing for all channels, whichever is higher.
- 10. Does not apply to customers who choose the PCO feature.

  - C. CONDITIONS

- (1) Service Charge includes all shipping, transportation, travel time, installation time, engineering and board/lodging (if required) expenses incurred during installation. A service charge will also be applied upon termination. This charge will cover the removal costs of the equipment at the remote customer site, including all shipping, transportation, travel time, labour, and board/lodging (if required) expenses incurred.
- (2) All calls placed from the Personal Calling Option (PCO) telephone are considered as Operator Assisted Long Distance calls which are subject to Transaction, Message and Operator-Assisted charges. Spacetime rates also apply unless Full Time service has been provided. Vancouver is the rate centre and all calls outside the Vancouver EAS are subject to Long Distance Message Toll rates.
- (3) The customer is responsible for providing housing, power, and the antenna site foundation meeting Company specifications. An Uninterrupted Power Supply (UPS) is required whenever site power is not generated by a public utility.
- (4) The customer will be billed actual cost for all transportation, travel time and board/lodging incurred during subsequent maintenance visits.
- (5) When service is interrupted the Company shall, at the customer's request, make a rebate in the charges except when the interruption is caused by the customer's negligence or failure of a local supply of electric energy. The rebate applies only to the monthly rate for the common equipment, channels and optional features. For each interruption the rebate is 1/30 of the monthly rate for each 24 hours during which the service is interrupted and shall be determined from the time the interruption is reported by the customer.
