## SITE ACCESS LICENSE FIRST RENEWAL AGREEMENT

THIS AGREEMENT made the 20th day of June, 2022

BETWEEN:

METCALFE REALTY COMPANY LIMITED (hereinafter called the "Licensor") OF THE FIRST PART

AND:

TELUS COMMUNICATIONS INC. (hereinafter called the "Licensee") OF THE SECOND PART

WITNESSETH:

WHEREAS, on the 23<sup>rd</sup> day of March, 2017, the parties hereto entered into a Site Access License Agreement for a Term of five (5) years beginning the 1<sup>nd</sup> day of April, 2017 and terminating on the 31<sup>nd</sup> day of March, 2022 for the non-exclusive right to install and maintain certain cable and fiber optic cable and such fixtures and attachments as necessary (the "Equipment) in the Building known as 161 Greenbank, in the City of Ottawa, in the Province of Ontario

AND WHEREAS, Telus Communications Company was dissolved and discontinued as a general partnership effective on October 1, 2017.

AND WHEREAS, on the 10<sup>th</sup> day of November, 2017, the parties hereto signed an Addendum to License stating that effective October 1, 2017, TELUS COMMUNICATIONS INC. assumed the License, and all right, title and interest thereunder, without limitations, as warranted in the Notice of Change of Corporate Name/Amendment dates August 31, 2017.

AND WHEREAS, the aforementioned there, and are referred to as the "Longe". License and the Addendum to License

NOW, THEREFORE, in consideration of the mutual covenants herein, and in the stated <u>Site Access</u> License Agrammant contained, the parties hereby agree that the Term of said License is renewed for a period of five (5) years ("First Renewal Term") commencing on the 1" day of April, 2022 and expiring on the 31" day of March, 2027 and that the said First Renewal Term is under the same terms, provisos and conditions as in the said Site how contained, save and except for the following: Access License, and Addanda

TERM AND FEE The existing clause shall be deleted and shall be replaced with the following:

TERM AND FEE

The First Renewal Term ("Term") of the License shall be for five (5) years commencing on the 1" day of April, 2022 and terminating on the 31" day of March, 2027.

The Licensee shall pay to the Licensor an annual License Fee of one thousand, two hundred dollars (\$1,200.00) plus H.S.T. payable in advance in one lump sum payment on the Commencement Date of the First Renewal Term of the License, and thereafter on each anniversary of the Commencement Date of the herein License.

In addition to the annual Licence Fee, the Licensee shall pay the Licensor any costs reasonably incurred by the Licensor for providing additional services in connection with the installation, maintenance, removal and operation of the Licensee's Equipment and Trade Fixtures (plus the costs of the Licensor's administrative fee of 15%) Such charges may include, without limitation, the fees charged by engineers, or other experts retained by the Licensor (including the Licensor's employees) for review and approval of plans, safety and security measures, escorted access, supervision, receiving, storing and handling of materials and articles, moving of materials and articles, removal of items or substances deposited or discharged on, in or about the Licenced Area or elsewhere in the Building as reasonably determined by the Licensor from time to time.

This SITE ACCESS LICENSE SECOND RENEWAL AGREEMENT shall enure to the benefit of and be binding upon the successors and assigns of the Parties hereto.
