TERM AND FEE

The First Renewal Term ("Term") of the License shall be for five (5) years commencing on the 1" day of April, 2022 and terminating on the 31st day of March, 2027.

The Licensee shall pay to the Licensor an annual License Fee of one thousand, two hundred and eighty dollars (\$1,280.00) plus H.S.T. payable in advance in one lump sum payment on the Commencement Date of the First Renewal Term of the License, and thereafter on each anniversary of the Commencement Date of the herein License.

In addition to the annual Licence Fee, the Licensee shall pay the Licensor any costs reasonably incurred by the Licensor for providing additional services in connection with the installation, maintenance, removal and operation of the Licensee's Equipment and Trade Fixtures (plus the costs of the Licensor's administrative fee of 15%) Such charges may include, without limitation, the fees charged by engineers, or other experts retained by the Licensor (including the Licensor's employees) for review and approval of plans, safety and ensuring measures essented access supervision receiving and handling of materials and articles. security measures, escorted access, supervision, receiving, storing and handling of materials and articles, moving of materials and articles, removal of items or substances deposited or discharged on, in or about the Licenced Area or clsewhere in the Building as reasonably determined by the Licensor from time to time.
