#### Central Office Link Arrangements for Interconnecting Canadian Carriers

## 211.1 **Service Description**

The arrangements contained in this Tariff Item are made available to registered Canadian Carriers and Digital Subscriber Line Service Providers (DSLSP). These central office link arrangements provide transmission paths from the Interconnecting Carrier's or DSLSP's co-located central office building space to the transport cross-connect panel within the central office for the purpose of transmitting at DS-1 and DS-3 speeds.

Because the Commission has forborne, in Telecom Regulatory Policy CRTC 2009-19, with respect to the regulation of this service as set out in that decision, the Company may also provide the service in this tariff at rates and on terms different from the tariffed rates and terms pursuant to an agreement entered into between the Company and a competitor that has been filed with the Commission for the public record.

**Definitions** 

For the purposes of this Tariff Item:

"Connecting Link" is a transmission path which connects a Company provided unbundled network component located or terminated within a Company Central Office ("CO") building or equivalent to a co-locator's transmission equipment located within a Company CO building or equivalent.

"Digital Subscriber Line Service Providers (DSLSP)" see Carrier Access Tariff (CRTC 21462), Item 102.

"DS-1 CO Link" is a connecting link that connects a Company provided network component to a co-locator's transmission equipment located within a Company CO. A DS-1 terminates at a transmission rate of 1.544Mbps.

"DS-3 CO Link" is a connecting link that connects a Company provided network component to a co-locator's transmission equipment located within a Company CO. A DS-3 terminates at a transmission rate of 44.736 Mbps.

#### 211.2 Conditions of Service - Continued

- 1. The Company does not make any representation that these arrangements shall at all times be available in the quantities requested and at the locations specified by the registered Canadian Carrier or DSLSP co-locating in the Company's Central Office(s). The Company shall, however, make every effort to make such arrangements available on request.
- 2. A CDN Other CO Connecting Link (copper-based) is required to connect a Connecting Link to any other service except a CDN Access. Rates and charges pursuant to CRTC 21462, Item 224.3.5 will apply for CDN Other CO Connecting Link (copper-based).
- 3. A DS-1 CO Link channelizing feature is available whenever the service application requires one which enables a DS-1 CO Link to be connected to DS-0 access facilities. The use of this feature will result in a monthly rate and service charges as specified in Item 211.3.2.
- 4. A DS-3 CO Link channelizing feature is available whenever the service application requires one which enables a DS-3 CO Link to be connected to DS-1 access facilities. The use of this feature will result in a monthly rate and service charges as specified in Item 211.3.2.
