

AIRPORT BOARD OF ADJUSTMENT

ORDER OF DECISION— ON FILE NO. HAS 2024-LV18

Date: August 20, 2024

The Airport Board of Adjustment held a meeting on August 20, 2024 to hear a request for a variance from Section(s) 9-503 and 9-504 of the Airport Compatible Land Use Regulations Ordinance to allow for the construction of single family residential development located at:

9802 Telephone Road, Houston, TX near William P. Hobby Airport
Parcel No. 0480010000235

The meeting was called to order at 6:02 PM with the following board members in attendance:

The public hearing on this item was opened at approximately 6:23 PM and closed by the chair following conclusion of all public comments. Bill Zrioka, representing Houston Airport System made opening comments and presented the staff report. Steve Garza, on behalf of Milestone Habitat Alameda, presented the request for the variance. There were no other speakers. The recording of the hearing, and exhibits received are included in the case file.

Following the presentation of evidence and discussion by the Board, Board Member Krause made a motion, to approve the request by the applicant

MOTION:

To approve variance HAS 2024-LV18, granting the requested variance and allow construction of single family residential development located approximately at 9802 Telephone Road, Houston, TX near William P. Hobby Airport, conditioned on appropriate sound attenuation measures. All construction to be completed in accordance with this variance and in compliance with all other city regulations and ordinances.

FINDINGS:

The Board finds that granting the variance is appropriate based on the evidence presented during the hearing. The Board specifically finds:

The latest FAA-approved 2015 Hobby Master Plan removes the extension of Runway 17-35 and, since the master plan approval, Runway 17-35 has been decommissioned and completely removed. Therefore, the applicant's proposed single-family project would be outside the proposed future 65 DNL noise contour in the 2003 Hobby Airport Master Plan and, in turn, outside of Tier One and in Tier Two if the Airport Compatible Land Use Ordinance were to be amended to reflect the removal of the Runway 17-35 and the associated noise contour change. Single-family is allowed in Tier Two with sound attenuation measures.


The Board further finds that granting the variance under these circumstances will result in substantial justice being done, not be contrary to the public interest, and is in accordance with the spirit of the airport hazard ordinance.

The motion was seconded by Board Member Jones.
