Question: Who is providing the signage? No information provided as to whose scope that is, 1. lettering font, etc. It shows up in DIV 10 in the specs.

Response: Signage is part of the scope of work. Font: ClearviewText Condensed Book, Size: 8".

2. Question: The section shows 1/4" stainless for the reveals, but 1/4" that is way over kill. 18 ga. would be better if they really need it.

Response: Yes, 18 ga is acceptable for reveals

3. Question: Perhaps the design can be reviewed to make the counters more constructible with less waste? The design as shown will have considerable unusable drop off making this a very expensive project. There are design considerations that really need to be discussed. Is there any way we can have a conversation?

Response: All bidders can make their recommendations for considerations with proposed cost savings, but without changing the design intent and/or finishes. No conversation can occur during the quiet period (from the end of the pre-bid conference until award).
