This Addendum is issued for the following reason:

## I. To Respond to Questions

1. **Question:** What are the working hours, is there a scheduled project plan? How many times do we have to mobilize?

**Response:** Per document 01110 Summary of Work, The Work that will be a hazard to the general public, such as overhead and ceiling work in the terminal, must be done at night between 11:00 p.m. and 5:00 a.m., as allowed by the owner. Mobilize before the said work schedule.

2. **Question:** Can we assume all work to be completed after hours?

**Response:** Work on the room identification signs next to doorways (not overhead), can be completed at any time, unless the contractor is impeding the movement of passengers or providing a safety risk to the public.

3. **Question:** Is this a Design Build, it looks like the drawings are fully complete?

Response: No, it is not a Design/Build.

4. **Question:** Throughout the drawing set there are several pages that have a large X across them and have a "NOT USED" label across the page. These pages can be found in both the Demolition scope, the Sign Location Plan, and the Message Schedule. Can you confirm if we should include these in our bid, or are these pages out of scope and should be excluded?

<u>Response</u>: These pages refer to the Exterior Signs (all sings on Curbside and beyond) which have been removed from the scope for this bid-set.

5. **Question:** There are 3 pages in the Demo portion of the project that do not have any Demo Plan Keyed Notes identified for the sign types called out. Please advise what keynotes should be included with these sign types.
