### 1.0 Purpose/Scope

At Stanwell, we are committed to the health and safety of our people and the environment where we operate. Our Safeguards embody the standards and practices that govern everything we do, ensuring that our highest priority is being 'Safe Today. Better Tomorrow'.

### 2.0 Stanwell Safeguards

The Stanwell Safeguards describe the controls and conditions that are critical in the control of our key Health, Safety and Environment (HSE) risks, and promote an overall focus on safety and fostering safe decision making.

The Safeguards form part of our work conditions. We do not compromise our health, safety and environment standards. **If it is not safe, STOP WORK and find a safer way**.

The Stanwell Safeguards are:

- 1. **Ensuring Effective Controls in Place** Ensure that the work scope and boundaries are established and that plant isolations and specific hazard controls are in place before commencing the job.
- 2. **Safe Work at Heights** Ensure you have fall protection and dropped objects controls in place before working at heights.
- 3. **Being Trained, Competent and Authorised** Only operate plant and equipment or perform work if you are trained, competent and authorised to do so.
- 4. **Safe Lifting** Follow safe lifting procedures and never walk under suspended loads.
- 5. **Safe in Confined and Restricted Spaces** Obtain authorisation and correct permits prior to entering confined spaces and restricted areas.
- 6. **Being Psychosocially Safe** Be respectful in your dealings with others and contribute to a healthy workplace free from harassment, bullying, vilification and discrimination.
- 7. **Safe Driving** Comply with all road rules and drive to the conditions when operating vehicles, mobile equipment or as a pedestrian.
- 8. **Not Altering Safety Devices** Safety protection devices, guards and barriers shall not be removed, bypassed, modified or inhibited without authorisation.
- 9. **Being Fit for Work** Be fit for work and unimpeded by alcohol, drugs, medication and fatigue.
- 10. **Chemical and Hazardous Substances** Ensure the safe handling, storing and disposal of any chemicals or hazardous substances you are working with.

All potential non-conformances of Stanwell's Safeguards will be investigated in accordance with Stanwell's Event Management Procedure (HSE - PROC-17 Event Management Business Procedure).

The outcomes for confirmed non-conformances will be determined based on the OHS-PROC-23 Safety Fair and Just Response Business Procedure and GOV-POL-30 Code of Conduct – The Way We Work at Stanwell.
