Stanwell's standing offer for ACT residential customers in Evoenergy's distribution region on flat tariffs and whose prices for the supply do not include a controlled load tariff is 9.09% less than the reference price, based on them consuming annual representative consumption of 6,100kWh. Their lowest annual price is \$2,432. No discounts apply under our standing offers. Each small business customer's bill will differ based on their actual usage.

2. Stanwell's standing offer for ACT residential customers in Evoenergy's distribution region on flat tariffs and whose prices for the supply includes a controlled load tariff is 11.04% less than the reference price, based on them consuming annual representative consumption of 6,100kWh of general usage and 2,500kWh of controlled load. Their lowest annual price is \$2,982. No discounts apply under our standing offers. Each small business customer's bill will differ based on their actual usage.

3. Stanwell's standing offer for ACT small business customers in Evoenergy's distribution region on flat tariffs and whose prices for the supply do not include a controlled load tariff is 5.92% less than the reference price, based on them consuming annual representative consumption of 10,000kWh. Stanwell's standing offer for ACT residential customers in Essential Energy's distribution region on flat tariffs and whose prices for the supply includes a controlled load tariff is 0.23% less than the reference price, based on them consuming annual representative consumption of 6,100kWh of general usage and 2,500kWh of controlled load. Their lowest annual price is \$3,224. No discounts apply under our standing offers. Each small business customer's bill will differ based on their actual usage.

Stanwell's standing offer for ACT small business customers in Essential Energy's distribution region on flat tariffs and whose prices for the supply do not include a controlled load tariff is 1.13% less than the reference price, based on them consuming annual representative consumption of 10,000kWh. Their lowest annual price is \$5,007. No discounts apply under our standing offers. Each small business customer's bill will differ based on their actual usage.
