1.0 Policy Statement

This Policy supports Stanwell's Values of *We care, We adapt* and *We deliver* so that, together, we create energy solutions now and into the future.

We work with our people, communities, stakeholders, partners and suppliers to deliver a secure supply of electricity, in a way that creates and drives a safe and healthy work environment, which safeguards our environmental and social right to operate.

2.0 Purpose/Scope

This policy applies to all employees of Stanwell Corporation and its subsidiaries, visitors and contractors while visiting or conducting business at Stanwell workplaces, and while participating in authorised activities outside of Stanwell workplaces.

Process Safety is managed separately through Stanwell's Asset Management Policy, Systems and Procedures, and is excluded from the scope of this Policy.

3.0 Our Commitments

We demonstrate our vision of *Safe Today, Better Tomorrow* and our commitment to our values by acting on the health, safety and wellbeing needs of our people, and by looking after each other, the environment and our community.

This is supported by our commitments to:

3.1 Provide a healthy and safe work environment

Stanwell fosters a culture of proactive and effective Health, Safety and Environmental (HSE) management, to achieve our vision of **Safe Today, Better Tomorrow**. We actively support and deliver health, wellbeing, psychosocial and sustainable environmental improvements in our workplaces, as we strive to enhance the health and wellbeing of our people and ensure our workplace is safe, respectful and inclusive. We identify, consider and mitigate Health, Safety and Environmental critical risks and impacts to ensure controls are in place and effective.

3.2 Deliver our Sustainability Strategy

We work collectively to achieve our sustainability commitments, which underpin how we do business. We continually challenge and adapt our approach to achieve better outcomes for our people, communities, stakeholders and the environment.

3.3 Realise our environmental objectives

We are responsible corporate citizens of the environment in which we operate. We are committed to environmental stewardship, pollution prevention, and making informed and sound business decisions with due consideration of environmental impacts and opportunities.

Stanwell demonstrates continuous improvement through our integrated ISO 45001:2018 and ISO 14001:2016 aligned Health, Safety and Environmental Management System (HSEMS).

4.0 Responsibilities

The Stanwell Board is responsible for the review and endorsement of this Policy and for ensuring the business systematically implements its health, safety and environmental commitments.

The Chief Executive Officer, Chief Operating Officer and Executive General Managers are responsible for providing resources to ensure required compliance, due diligence commitments and endorsement of health, safety and environmental objectives and targets that demonstrate continual improvement.

All employees and contractors are responsible for:

- using the Health, Safety and Environmental Management System to identify, assess and control health, safety and environmental risks in the workplace. If it is determined that effective controls are not in place, our people are empowered to stop work and find a safer way;
- reporting and investigating all events and non-conformances;
- applying fair and just corrective outcomes;
- communicating shared learnings to prevent recurrence;
- attending work fit for duty, unimpaired by drugs, alcohol or fatigue; and
