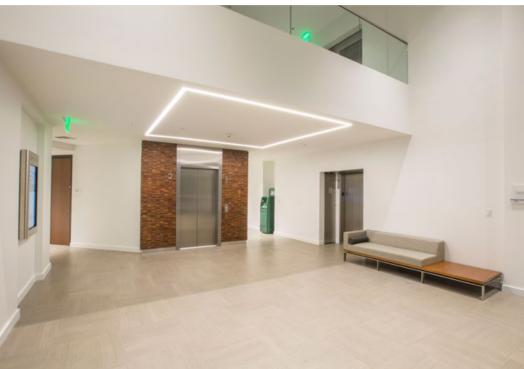

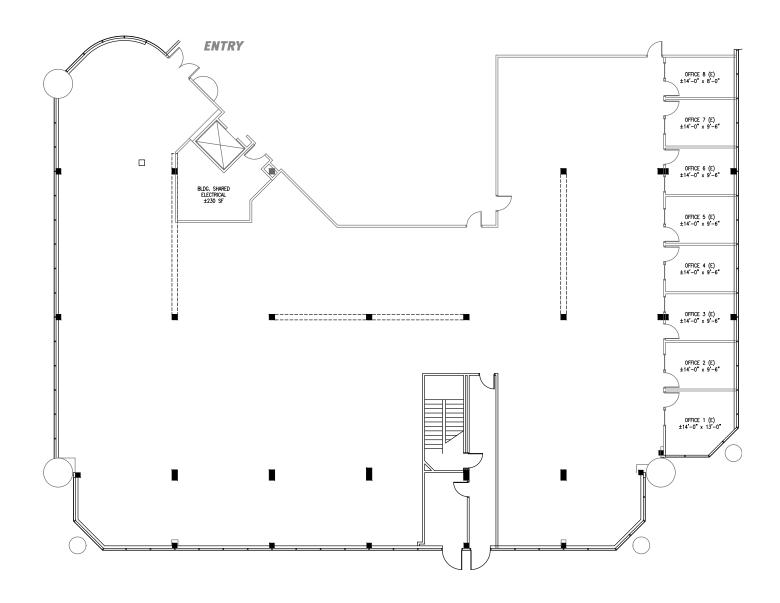

FLOOR PLAN | 12626 HIGH BLUFF DRIVE | SUITES 100/125

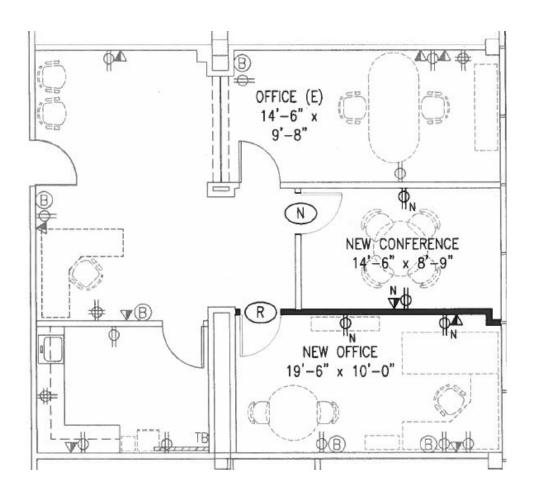

FLOOR PLAN | 12636 HIGH BLUFF DRIVE | SUITES 100/150

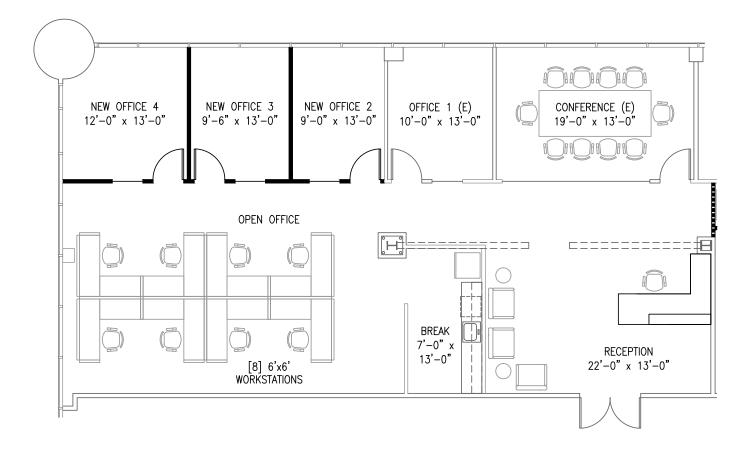
