ST MUNGO'S - HOMELESSNESS

St Mungo's firmly believe in a recovery-centred approach to ending homelessness. At the heart of everything they do is their mission to empower people to live fulfilling lives and prevent homelessness in the future. Their Recovery College is a key part of this approach. They run four Recovery Colleges across the country designed to enable those who are homeless, or at risk of homelessness, to fulfil their potential. They offer one-to-one progression coaching and specialist employment including CV writing and interview preparation, as well as brokering opportunities directly with employers.

THE PRINCE'S TRUST - YOUNG PEOPLE

In these times of great uncertainty, it has never been more important to support the most vulnerable young people – our future workforce and leaders - to help rebuild the economy. The Prince's Trust changes the lives of hundreds of young people across London and the UK through employment programmes and confidence building workshops.

MAGGIES - CANCER SUPPORT

Maggie's acknowledges the excellent medical care and treatment that health services provide but they know that professionals don't have the time to sit with a person to discuss their wider concerns and needs. The majority of people with cancer need additional practical, emotional and social support to complement the excellent medical treatment that the NHS provides. Maggie's provides this support, for free, including a 'Back to Work Scheme' for people living with cancer.

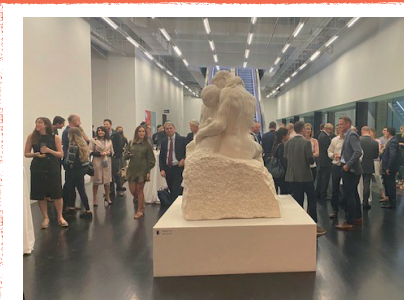
