Ladbrokes Twenty 20 Tip Off (Cricket)

Terms and Conditions

- 1. The promoter is Ladbrokes Digital Australia Pty Ltd (ABN 25 151 956 768) of 461-473 Lutwyche Road, Lutwyche Queensland, 4030, phone 1300 523 276 (**Promoter**). The Promoter and its related companies are referred to as the **Promoter Group**.
- 2. Instructions and information on how to enter the promotion form part of these terms and conditions, and entry into the promotion is deemed acceptance of these terms and conditions and all of the Promoter's terms and conditions.
- 3. The Promotion will run on selected matches and dates between 17 December 2018 at 12:00am to 11 February 2019 at 6pm. (**Promotion Period**).
- 4. The promotion will have 8 groups of matches within the Promotion Period as outlined in table below (**Promotion Sub-Periods**);

5. Entry to the Promotion is free. Entry is open to residents of Australia who are 18 years of age or older and who have a current customer account with the Promoter.

- 6. The following people are not eligible to win any prizes resulting from this promotion:
 - a) directors, managers, agents, employees of the Promoter Group and their immediate families; and
 - a person whose betting account with the Promoter Group is restricted in any way (including with respect to Ladbrokes promotions), suspended or inactive due to a Responsible Gambling concern or for another reason.
- 7. Entrants may access the Promotion by logging into their Ladbrokes Account on their desktop browser or via a Ladbrokes app, and navigating to the 'Ladbrokes Twenty 20 Tip Off (Cricket)' Free to Play Game site (https://www.ladbrokes.com.au/free-to-play-games) (the Game site).
- 8. The entrant will then be permitted to make selections relating to upcoming Twenty 20 Cricket Big Bash matches ('Main Gameplay'). For each of the matches on the specified days between the Promotion sub-Period the entrant must make the following selections:
 - a. the team to win the match (Win);
 - b. which team will hit the most sixes in the match (Most Sixes);
- 9. A 'Captain's Call Feature' (Pick The Winning Score) will be used on one match within each Promotion sub-Period. The "Captain's Call Match" will be the last scheduled match of the Promotion sub-Period. The entrants will be presented with a slider that allows them to choose the number of runs they believe the winning team will score. The number of runs that can be selected will range between 0 and 400. Entrants are scored based upon how close they are to the final winning number of runs.
- 10. The 'Captain's Call Feature' is used as a tiebreaker if there's more than one entrant with the same score. If, for example, you predict that the winning team scores 245 runs, and they score 260, you'll receive a Margin score of 15 (the difference between your prediction and the actual result). Your margin is recorded just for that Promotion sub-Period, where tipping scores are tied the entrant with the lowest margin score is ranked highest.
- 11. With regard to the 'Captain's Call Feature', if an entrant picks the exact score, they are awarded 0 points.
- 12. 'Main Gameplay' and 'Captain's Call Feature' points are not aggregated. They are recorded separately. The 'Captain's Call Feature' points are only used as a means to differentiate between entrants who score the same number of points in the 'Main Gameplay'.
- 13. Entrants will be able to submit their selections for each nominated Twenty 20 Cricket Big Bash matches from at least 9:00am the day before the advertised start time of that first match within the Promotion sub-Period.
- 14. Entrants will be able to amend their selections only up until the advertised start time for the associated match, after which entry for that match is closed and selections for the match will no longer be accepted.

- 15. Unless otherwise stated, the results for **Win** and **Most Sixes** will be decided based on the official www.cricket.com.au and www.bigbash.com.au scores at the completion of play (the Outcome).
- 16. All match betting will be settled in accordance with official competition rules.
- 17. Only sixes scored from the bat (off any delivery legal or not) will count towards the total sixes. Overthrows and extras do not count.
- 18. Sixes scored in a super over do not count.
- 19. If a tie occurs for most sixes, points will be awarded as half face value of the Ladbrokes SP fixed odds price x virtual \$10AUD.
- 20. In matches affected by adverse weather, selections will be settled according to the official result. This includes matches affected by a mathematical calculation such as the Duckworth-Lewis method (DL) or the Jayadevan system (VJD).
- 21. In the case of a tie, where a bowl off or super over determines a winner, bets will be decided based on the official www.cricket.com.au and www.bigbash.com.au scores at the completion of play (the Outcome).
- 22. Should a match be postponed after the start time for that match, all selections relating to that match will stand until the match is played and completed. Should a match be abandoned, cancelled or not completed, all selections for that match will be classed as void. If there is no official result for a match, all selections will be void.
- 23. To determine the scoring, each selection from each entrant will be allocated a virtual equivalent of \$10AUD. The virtual \$10 will then be used to calculate a dividend, based on the Ladbrokes SP or Fixed Price associated with the entrant's selections as at the advertised start time for the match, and on the Outcome for that match. The dividend will represent the entrant's score associated with that particular selection.

For example, where an entrant successfully tips a match with an associated Ladbrokes Fixed Price or SP of \$1.70 (Win) and \$4.00 (Most Sixes), the entrant's score for that match would be calculated by multiplying the SP or Fixed Win Price with the virtual \$10, then subtracting the virtual \$10 from the total amount. This process would then be repeated with the additional virtual \$10 and the SP or Fixed Most Sixes Price, with both sets of points then added to form the entrant's total points for that match. For example:

It is possible for an entrant to tip the incorrect Win market, but tip the correct Most Sixes market result. In this case, the entrant will receive points in accordance with the above

calculation for the Most Sixes market, but will receive no points in relation to their tip for the Win market.

It is also possible for an entrant to tip the correct Win market, but tip the incorrect Most Sixes market. In this case, the entrant will receive points in accordance with the above calculation for the Win market, but will receive no points in relation to their tip for the Most Sixes Market.

As the price for each selection will be calculated based on the official Ladbrokes SP or Fixed Price as at the advertised start time for the match, the price shown at the time the entrant is making their selections may be different to the price used for score calculation purposes.

- 24. Each Monday, the Promoter will tally the scores earned by the entrants for the preceding week's Twenty 20 Cricket Big Bash matches as outlined in the Promotion sub-Periods.
- 25. Each Promotion sub-Period will have associated prizes that will be awarded to the entrants whose selections have generated the highest scores for that sub-Period (being the largest total amount of dividends). The prizes available for each Promotion sub-Period will be as follows:

- 26. The following conditions apply to the prizes:
 - a. Where the 'Main Gameplay' scoring results in a dead heat among entrants for a particular prize the 'Captain's Call Feature' is used as a tiebreaker if there's more than one entrant with the same score.

- b. For Example; Where there are three entrants who are in a dead heat for first place, the top three prizes will be then paid accordingly based on lowest to highest 'Captain's Call Feature' scores.
- c. All relevant prizes equal to the number of entrants involved in the dead heat initially will be paid among those entrants.
- d. The share of the cash prize will be deposited into the prize winner's Ladbrokes account. Prizes can take up to 14 days' to reach a winner's account.
- e. Should it be identified that an entrant has breached the Promoter's Terms of Use while participating in the Promotion, that entrant will be deemed ineligible for any prizes.
- f. Where a prize winner is deemed ineligible, or is unable to receive their prize, the Promoter reserves the right to disqualify that participant and award the prize to the eligible entrant (or entrants) with the next highest score, if applicable.
- g. The prize winners must do everything required of them to accept and take delivery of the prize within 14 days of being notified that they are a prize winner, including verifying their identity with the Promoter to the Promoter's satisfaction.
- h. If the prize winner fails to comply with clause 26(e), the prize winner will be deemed ineligible, their right to the prize will be forfeited and they will not be compensated in any way;
- i. If the prize (or a component of it) is not available for any reason, we reserve the right to substitute the prize with another of similar value;
- j. The right to the prize is not transferable or assignable to another person (other than in accordance with clause 26(g); and
- k. Any taxes which may be payable as a result of receiving a prize are the sole responsibility of the prize winner.
- 27. The total retail value for all prizes is \$16,160. (\$2,020 per Promotion sub-Period).
- 28. The Promoter's decision as to the results of the Promotion are final and no correspondence will be entered into.
- 29. The Promoter will attempt to notify prize winners via the telephone number and email address listed on their Ladbrokes accounts within 72 hours after the Outcome of that match is known. It is the entrant's responsibility to ensure that the phone number and email address listed on their Ladbrokes account is up to date. The Promoter may also announce or publish the name and suburb or town of the prize winners in any media, including social media.
- 30. The Promoter reserves the right, at any time, to verify the validity of any entry or disqualify any entrant who submits an entry that is not in accordance with these terms and conditions or the Promoter's Terms and Conditions (available at https://www.ladbrokes.com.au/terms-and-conditions/) or who tampers with the entry process. The decision to verify, validate or disqualify an entry is in the Promoter's absolute discretion.
- 31. The Promoter reserves the right to cancel, withdraw or suspend the Promotion at any time. If the Promoter reasonably considers that a change to these terms and conditions is likely to benefit entrants or be of immaterial detriment to entrants, then the Promoter can make the change immediately and does not need to notify entrants. Alternatively, the Promoter

- may vary these terms and conditions by placing a notification at all places where these terms and conditions are made available to entrants.
- 32. The Promoter accepts no responsibility for late, lost or misdirected entries. Beyond the reasonable control of the Promoter, the Promoter cannot be held liable for, and accepts no responsibility for any postponement, cancellation, delay or changes to the Promotion, prizes or relevant Twenty 20 Cricket Big Bash matches; any technical failures or unavailability of the Game Site or other related platform; any printing or typographical errors in any material or information associated with the Promotion; or any act or default of any third-party supplier including without limitation errors relating to fixtures, pricing and scoring data. The Promoter is not responsible for any problems or technical malfunction of any computer system, software or internet difficulties, including any damage to an entrant's device, resulting from participating in the promotion. Any cost associated with participating in the promotion is the entrant's responsibility.
- 33. The Promoter will not be liable for any loss or damage or personal injury suffered or sustained in relation to the promotion or a prize except for any liability which cannot be excluded by law.
- 34. If the Promoter is prevented from or delayed in performing an obligation by Force Majeure then the obligation is suspended during, but for no longer than, the period the Force Majeure continues and any further period that is reasonable in the circumstances. 'Force Majeure' means any event beyond the reasonable control of the Promoter, which occurs without the fault or negligence of the Promoter.
- 35. Subject to obtaining the approval from the regulator (if applicable), the Promoter reserves the right to delay or modify any aspect of this promotion if for any reason it is not capable or running as planned (including without limitation, by reason of infection by computer virus, bugs, tampering, fraud, technical failures, power failures or due to any other causes unforeseen or beyond the reasonable control of the Promoter which corrupt or affect the administration, security, fairness, integrity or proper conduct of the promotion) but only to the extent necessary to overcome the issue that is affecting the running of the promotion as planned.
- 36. By participating in the promotion, an entrant authorises the Promoter Group, and contractors and agents of the Promoter Group, to access, collect and use personal information about the entrant, and disclose personal information about the entrant, to the Promoter Group and its contractors and agents, for the purposes of (i) conducting the promotion; (ii) providing the entrant with information and marketing material about products and services of the Promoter Group; and (iii) making arrangements for a prize winner to be notified and receive their prize. Such information may be provided electronically, or by contacting the entrant by telephone or other means, until such time as the entrant asks the Promoter not to provide further information. The Promoter's Privacy Policy (available at www.ladbrokes.com.au/terms-and-conditions/) contains information about how to access, correct or make a complaint about the Promoter's handling of personal information. A prize winner may be asked by the Promoter to participate in publicity associated with the promotion. The prize winner will have the right to elect whether or not to participate in that publicity.

- 37. If an entrant does not provide the personal information requested, the entrant cannot participate in the promotion and will not receive information about products and services of the Promoter Group.
