## Ladbrokes Stony Pony Dash

### Terms and Conditions

1. The promoter is Ladbrokes Digital Australia Pty Ltd (ABN 25 151 956 768) of 461-473 Lutwyche Road, Lutwyche Queensland, 4030, phone 1300 523 276 (**Promoter**). The Promoter and its related companies are referred to as the **Promoter Group**.
2. Instructions and information on how to enter the promotion form part of these terms and conditions, and entry into the promotion is deemed acceptance of these terms and conditions and all of the Promoter's terms and conditions.
3. Entry is free and automatic when you either:
  - a. complete and submit an entry form via the Ladbrokes iPads held by Ladbrokes promotional staff roaming at Stony Creek Racing Club during the Stony Creek Racing Club meetings on Saturday 29th December, Wednesday 9th January, Friday 1st February, Wednesday 13th February; or
  - b. complete and submit an entry form via an on-line entry form and submit it to the Promoter via the Ladbrokes website,  
  
between 12:00pm 29 December 2018 until 5:00pm 1 March 2019 (**Promotion Period One**)
4. Entry is free and automatic when you either:
  - a. complete and submit an entry form via the Ladbrokes iPads held by Ladbrokes promotional staff roaming at Stony Creek Racing Club during the Stony Creek Racing Club meeting on Sunday 10<sup>th</sup> March; or
  - b. complete and submit an entry form via an on-line entry form and submit it to the Promoter via the Ladbrokes website,  
  
between 11:00am 10 March 2019 until 1:00pm 10 March 2019 (**Promotion Period Two**).
5. Entry is open to residents of Victoria who are 18 years of age or older who:
  - a. have an account with the Promoter;
  - b. are available to compete in the Ladbrokes Stony Pony Dash – a 100 metre running race to take place on 10 March 2019 at Stony Creek Racing Club just prior to the Ladbrokes Stony Creek Cup race) (**Dash**);
  - c. will be present at Stony Creek Racing Club on 10 March 2019 at the time of the draw (Promotion Period Two entrants only)
  - d. agree to these Competition Terms and Conditions; and
  - e. agree and sign the Competition Waiver document.

6. Entrants can have only one entry in promotion period.
7. Directors, managers, agents, employees of the Promoter Group and their immediate families are not eligible to win any prizes resulting from this promotion.
8. 8 entries will be drawn randomly by computer at 9:00am on 4 March 2019 at 461-473 Lutwyche Road, Lutwyche Queensland 4030 to compete in the Dash (**Initial Draw**)
9. Two (2) entries will be drawn on 10 March 2019 from Promotion Period Two entries, at Stony Creek Racing Club at 23 Stony Creek-dollar Rd, Stony Creek, VIC 3957, 60 minutes before the Ladbrokes Stony Creek Cup race, and be contacted by telephone.
10. The first eight valid entries drawn on 4 March 2019, and the first two valid entries drawn on 10 March 2019 will win the opportunity to compete in the Dash. The Promoter's decision as to the result of the Initial Draws is final and no correspondence will be entered into.
11. The Promoter will attempt to notify the entries drawn in clause 8 via telephone and email immediately after the draw. We may also announce or publish the first initial, surname and suburb or town of the prize winners in any media, including social media.
12. If an entry drawn under clause 8 is unable to be contacted within 48 hours, their right to enter the Dash will be forfeited and they will not be compensated in any way. We may conduct such further draws at the same place as the original draw as are necessary 48 hours after the draw outlined in clause 8 in order to offer any unclaimed opportunity to take part in the Ladbrokes Stony Pony Dash, as determined by us in our absolute discretion, subject to any directions given by a responsible authority under any relevant regulation.
13. The Promoter will attempt to notify the entries drawn in clause 9 via telephone immediately after the draw.
14. If an entry drawn under clause 9 is unable to be contacted immediately by telephone (after two attempts), or they are not present at Stony Creek Racing Club at the time of the draw, their right to enter the Dash will be forfeited and they will not be compensated in any way. We may conduct such further draws at the same place as the original draw as are necessary in order to offer any unclaimed opportunity to take part in Dash, as determined by us in our absolute discretion, subject to any directions given by a responsible authority under any relevant regulation.
15. Each valid entry drawn in the Initial Draw will receive the following:
  - a. entry to the racecourse for them self and one guest on 10 March 2019;
  - b. awarded with \$50 worth of bonus bets.
16. The prizes for the Dash are:

- a. 1st place – Two all-inclusive tickets into the Ladbrokes Lounge at Moonee Valley on Friday 22nd March (William Reid stakes Night); meet and greet with Peter Moody (or ambassador on the night); and \$500 bonus bet into a Ladbrokes account;
  - b. 2nd place – Two all-inclusive tickets into the Ladbrokes Lounge at Moonee Valley on Friday 22nd March (William Reid Stakes Night); and \$300 bonus bet into a Ladbrokes account; and
  - c. 3rd place – \$200 bonus bet into a Ladbrokes account.
17. The Promoter’s decision as to the result of the Dash is final and no correspondence will be entered into.
18. The retail value for the prize pool is up to \$3468 AUD.
19. The following conditions apply to the prize:
  - a. The prize is limited to the items listed in clause 16, and any additional costs or charges must be paid by the winner;
  - b. The tickets are only able to be used by persons who are 18 years of age or older;
  - c. The prize winner must do everything required of them to accept and take delivery of the prize within a reasonable period of time;
  - d. If the prize winner fails to comply with clause 19(c), their right to the prize will be forfeited and they will not be compensated in any way;
  - e. If a prize (or a component of it) is not available for any reason, we reserve the right to substitute the prize with another of similar value, or at our discretion, with a cash sum equivalent to the retail value of that component of the prize; and
  - f. The right to any prize is not transferable or assignable to another person, and the prize is not redeemable for cash (other than in accordance the 19(e)).
20. The Promoter reserves the right, at any time, to verify the validity of any entry or disqualify any entrant who submits an entry that is not in accordance with these terms and conditions or who tampers with the entry process. The decision to verify, validate or disqualify an entry is in the Promoter’s absolute discretion.
21. If the Promoter reasonably considers that a change to these terms and conditions is likely to benefit entrants or be immaterial detriment to entrants, then the Promoter can make the change immediately and does not need to notify entrants. Alternatively, the Promoter may vary these terms and conditions by placing a notification at all places where these terms and conditions are made available to entrants.
22. The Promoter accepts no responsibility for late, lost or misdirected entries. The Promoter is not responsible for any problems or technical malfunction of any computer system, software or internet difficulties, including any damage to an entrant’s device, resulting from participating in the promotion. Any cost associated with participating in the promotion are the entrant’s responsibility.
23. The Promoter will not be liable for any loss or damage or personal injury suffered or sustained in relation to the promotion or a prize except for any liability which cannot be excluded by law. All entries drawn under clause 8 and clause 9 must sign a Competition

Waiver document prior to the Dash, otherwise, their right to enter the Dash will be forfeited and they will not be compensated in any way.

24. If the Promoter is prevented from or delayed in performing an obligation by Force Majeure then the obligation is suspended during, but for no longer than, the period the Force Majeure continues and any further period that is reasonable in the circumstances. 'Force Majeure' means any event beyond the reasonable control of the Promoter, which occurs without the fault or negligence of the Promoter.
25. Subject to obtaining the approval from the regulator (if applicable), the Promoter reserves the right to delay or modify any aspect of this promotion if for any reason it is not capable or running as planned (including without limitation, by reason of infection by computer virus, bugs, tampering, fraud, technical failures, power failures or due to any other causes unforeseen or beyond the reasonable control of the Promoter which corrupt or affect the administration, security, fairness, integrity or proper conduct of the promotion) but only to the extent necessary to overcome the issue that is affecting the running of the promotion as planned.
26. By participating in the promotion, an entrant authorises the Promoter Group, and contractors and agents of the Promoter Group, to access, collect and use personal information about the entrant, and disclose personal information about the entrant, to the Promoter Group and its contractors and agents, for the purposes of (i) conducting the promotion and (ii) providing the entrant with information and marketing material about products and services of the Promoter Group. Such information may be provided electronically, or by contacting the entrant by telephone or other means, until such time as the entrant asks the Promoter not to provide further information.
