World Cup Sweeps

Terms and Conditions

1. The promoter is Ladbrokes Digital Australia Pty Ltd (ABN 25 151 956 768) of 461-473 Lutwyche Road, Lutwyche Queensland, 4030, phone 1300 523 276 (**Promoter**). The Promoter and its related companies are referred to as the **Promoter Group**.
2. Instructions and information on how to enter the promotion form part of these terms and conditions, and entry into the promotion is deemed acceptance of these terms and conditions and all of the Promoter's terms and conditions.
3. Entry to the promotion is free and automatic when you click 'Enter the Sweep' on the World Cup Sweep Landing Page, sign up to a Ladbrokes account and deposit \$10.00AUD into that account.
4. Entry to the promotion is open from 9:00am Monday 4 June 2018 until 12:00pm Thursday 14 June 2018 (**Promotion Period**).
5. Entry is open to residents of QLD, NT, ACT and TAS who are 18 years of age or older and who do not have an account with the Promoter at the time of entry.
6. Residents of NSW, VIC, SA and WA are excluded from entering the promotion and are not eligible to win any prizes resulting from this promotion.
7. Directors, managers, agents, employees of the Promoter Group and their immediate families are not eligible to win any prizes resulting from this promotion.
8. Entrants can only have one entry in the promotion.
9. Immediately upon entry, each entrant will be allocated one of the 32 teams participating in the FIFA 2018 World Cup. The entrant will be notified of the team they have been allocated via the email address providing to Ladbrokes when creating their Ladbrokes account at 5:00pm 14 June 2018.
10. The prize for the promotion is \$10 in bonus bets deposited into a Ladbrokes account each time the entrant's allocated team scores a goal throughout the FIFA 2018 World Cup (excluding any goals scored during a penalty shoot-out as stated in clause 12(c)).
11. The total retail value for all prizes to be allocated as part of this promotion is up to \$50,000 AUD.
12. The following conditions apply to the prize:

- a. The prize is subject to Ladbrokes Terms and Conditions, including turnover requirements, which are available on the Ladbrokes website.
 - b. For the purpose of this promotion and in accordance with clause 1.9 of the Ladbrokes Sports Betting Rules, goals will be determined based on first official match results from FIFA. Any subsequent corrections or amendments to this result will not apply with respect to allocation of bonus bets.
 - c. Goals scored during a penalty shoot-out at any time during a FIFA 2018 World Cup match will not be classed as a 'goal' for the purpose of this promotion.
 - d. If a prize (or a component of it) is not available for any reason, we reserve the right to substitute the prize with another of similar value, or at our discretion, with a cash sum equivalent to the retail value of that component of the prize, subject to state lottery laws; and
 - e. The right to any prize is not transferable or assignable to another person, and the prize is not redeemable for cash (other than in accordance with clause 12(b)).
13. The Promoter's decision as to the result of the prizes is final and no correspondence will be entered into.
14. Entrants will be able to identify when they have won a \$10 bonus bet by checking their bonus bet account balance by signing in to their Ladbrokes account via the Ladbrokes app or the Ladbrokes website.
15. The Promoter reserves the right, at any time, to verify the validity of any entry or disqualify any entrant who submits an entry that is not in accordance with these terms and conditions or who tampers with the entry process. The decision to verify, validate or disqualify an entry is in the Promoter's absolute discretion.
16. Subject to state lottery laws, if the Promoter reasonably considers that a change to these terms and conditions is likely to benefit entrants or be immaterial detriment to entrants, then the Promoter can make the change immediately and does not need to notify entrants. Alternatively, subject to state lottery laws, the Promoter may vary these terms and conditions by placing a notification at all places where these terms and conditions are made available to entrants.
17. The Promoter accepts no responsibility for late, lost or misdirected entries. The Promoter is not responsible for any problems or technical malfunction of any computer system, software or internet difficulties, including any damage to an entrant's device, resulting from participating in the promotion. Any cost associated with participating in the promotion are the entrant's responsibility.
18. The Promoter will not be liable for any loss or damage or personal injury suffered or sustained in relation to the promotion or a prize except for any liability which cannot be excluded by law.
19. If the Promoter is prevented from or delayed in performing an obligation by Force Majeure then the obligation is suspended during, but for no longer than, the period the Force Majeure continues and any further period that is reasonable in the circumstances. 'Force

Majeure' means any event beyond the reasonable control of the Promoter, which occurs without the fault or negligence of the Promoter.

20. Subject to obtaining the approval from the regulator (if applicable), the Promoter reserves the right to delay or modify any aspect of this promotion if for any reason it is not capable or running as planned (including without limitation, by reason of infection by computer virus, bugs, tampering, fraud, technical failures, power failures or due to any other causes unforeseen or beyond the reasonable control of the Promoter which corrupt or affect the administration, security, fairness, integrity or proper conduct of the promotion) but only to the extent necessary to overcome the issue that is affecting the running of the promotion as planned.
21. By participating in the promotion, an entrant authorises the Promoter Group, and contractors and agents of the Promoter Group, to access, collect and use personal information about the entrant, and disclose personal information about the entrant, to the Promoter Group and its contractors and agents, for the purposes of (i) conducting the promotion, (ii) providing the entrant with information and marketing material about products and services of the Promoter Group and (iii) making arrangements for a prize winner to be notified and receive their prize. Such information may be provided electronically, or by contacting the entrant by telephone or other means, until such time as the entrant asks the Promoter not to provide further information. The Promoter's Privacy Policy (available at www.ladbrokes.com.au/terms-and-conditions/) contains information about how to access, correct or make a complaint about the Promoter's handling of personal information. A prize winner may be asked by the Promoter to participate in publicity associated with the promotion. The prize winner will have the right to elect whether or not to participate in that publicity.
