Viclads 2018 Ladbrokes AFL Tipping Competition

Terms and Conditions

1. The promoter is Ladbrokes Digital Australia Pty Ltd (ABN 25 151 956 768) of 461-473 Lutwyche Road, Lutwyche Queensland, 4030, phone 1300 523 276 (**Promoter**). The Promoter and its related companies are referred to as the **Promoter Group**.
2. Instructions and information on how to enter the promotion form part of these terms and conditions, and entry into the promotion is deemed acceptance of these terms and conditions and all of the Promoter's terms and conditions.
3. Entry to the promotion is free and automatic when you successfully sign up to the Viclads 2018 Ladbrokes Tipping Competition on footytips.com.au, hosted by ESPN Footytips (**Footytips**), which can be found at <http://www.footytips.com.au/comp/viclads2018>.
4. Entry to the competition will be open from 12:00am 26 March 2018 to 11:59pm 24 August 2018.
5. Entry to the promotion is open to residents of Australia who are 18 years of age or older.
6. The following people are not eligible to win any prizes resulting from this promotion:
 - a) directors, managers, agents, employees of the Promoter Group and their immediate families;
 - b) directors, managers or employees of businesses associated with the promotion, including Footytips; and
 - c) an entrant who has a betting account with the Promoter Group which is either suspended or inactive due to a Responsible Gambling concern or for another reason.
7. The prizes for the promotion are
 - a. First prize:
 - i. Tickets for the winner and one nominated guest to attend either the Ladbrokes suite at Caulfield Racecourse at Station Street, Caulfield East, Victoria or the Ladbrokes Lounge at Moonee Valley at Moonee Ponds, Victoria (**Moonee Valley**), to be determined by the prize winner and on a date to be nominated by the prize winner from a selected number of dates to be provided by the promoter;
 - ii. Tickets for the winner and one nominated guest to attend an AFL football game at the Ladbrokes Box at the Melbourne Cricket Ground, East Melbourne, Victoria, on a date to be nominated by the prize winner from a selected number of dates to be provided by the promoter;

- iii. Tickets to attend and play in the Ladbrokes Victoria Golf Day at Woodlands Golf Club, 109 White Street, Mordialloc, Victoria in April 2019 (specific date to be advised); and
 - iv. \$1,000 bonus bet voucher, to be deposited into a Ladbrokes account.
 - b. Second prize:
 - i. \$1,000 bonus bet voucher, to be deposited into a Ladbrokes betting account.
 - ii. 2 x tickets to the Ladbrokes Lounge at Moonee Valley, including food and beverages to attend a Moonee Valley race meeting, with the exception of the Cox Plate Carnival.
 - c. Third Prize:
 - i. \$500 bonus bet voucher, to be deposited into a Ladbrokes betting account.
 - ii. 2 x tickets to the Ladbrokes Lounge at Moonee Valley, including food and beverages to attend a Moonee Valley race meeting, with the exception of the Cox Plate Carnival.
 - d. Round 12 Leader:
 - i. 2 x tickets to the Ladbrokes suite at Caulfield Racecourse at Station Street, Caulfield East, Victoria.
- 8. Entrants can have only one Footytips account entered in the promotion.
- 9. The first, second and third prize winners will be chosen based on their respective end of Season rankings as determined by Footytips in accordance with their terms and conditions, available [here](#). The First Prize will be awarded to the entrant who has the highest Season ranking, second place will be the person with the second highest Season ranking, and so forth.
- 10. The Round 12 Leader prize will be awarded to the entrant who is the Round 12 Leader, as determined by Footytips in accordance with the footytips.com.au terms and conditions.
- 11. The following conditions apply to the prize:
 - a. The prize does not include any insurance;
 - b. The items in clause 7 can only be used by people who are 18 years of age or older;
 - c. The prize is subject to terms and conditions (including turnover requirements) available at www.ladbrokes.com.au/terms-and-conditions/, as well as the Footytips terms and conditions;
 - d. The prize is limited to the items listed in clause 7, and any additional costs or charges must be paid by the winners, including but not limited to any additional travel costs, etc;
 - e. The prize winners must do everything required of them to accept and take delivery of the prize before 1 December 2018, including the provision of nominated venues, dates and times for the hospitality events outlined in clause 7;
 - f. The Promoter will consider nominated venues, dates and/or times for the hospitality events as outlined in clause 7, however the Promoter will have the final decision regarding the venues, dates and/or times for all tickets.
 - g. If the prize winner fails to comply with clause 9(e), their right to the prize will be forfeited and they will not be compensated in any way;
 - h. If the prize (or a component of it) is not available for any reason, we reserve the right to substitute the prize with another of similar value, or at our discretion, with a cash sum equivalent to the retail value of that component of the prize; and

- i. The right to the prize is not transferable or assignable to another person, or redeemable for cash (other than in accordance with clause 9(h)).
12. The retail value for the prizes are:
 - a. First Prize: \$3,100.00
 - b. Second Prize: \$1500.00
 - c. Third Prize: \$1000.00
 - d. Round 12 Leader: \$700.00
13. The Promoter's decision as to the result of the prize is final and no correspondence will be entered into.
14. The Promoter will attempt to notify the prize winners via the telephone number and email address provided by the prize winner upon entry within 72 hours after the competition has ended. We may also announce or publish the first initial, surname and suburb or town of the prize winners in any media, including social media.
15. If a prize winner is unable to be contacted within 72 hours after the competition has ended, then that person's right to the prize is forfeited and the prize will be distributed to the next most successful entrant in either the Season rankings or in Round 12 (as relevant). Should this person already be eligible for a prize, this person will receive the prize of greater value, and the subsequent next most successful person will receive their prize. For example, if the winner of the First Prize is unable to be contacted in accordance with this section, the person who would have otherwise received the Second Prize becomes eligible to receive the First Prize; the person who would have otherwise received the Third Prize becomes eligible to receive the Second Prize; and so forth.
16. The Promoter reserves the right, at any time, to verify the validity of any entry or disqualify any entrant who submits an entry that is not in accordance with these terms and conditions or who tampers with the entry process or in any way breaches the FootyTips terms and conditions. The decision to verify, validate or disqualify an entry is in the Promoter's absolute discretion.
17. If the Promoter reasonably considers that a change to these terms and conditions is likely to benefit entrants or be immaterial detriment to entrants, then the Promoter can make the change immediately and does not need to notify entrants. Alternatively, the Promoter may vary these terms and conditions by placing a notification at all places where these terms and conditions are made available to entrants.
18. The Promoter accepts no responsibility for late, lost or misdirected entries. The Promoter is not responsible for any problems or technical malfunction of any computer system, software or internet difficulties, including any damage to an entrant's device, resulting from participating in the promotion. Any cost associated with participating in the promotion are the entrant's responsibility.
19. The Promoter will not be liable for any loss or damage or personal injury suffered or sustained in relation to the promotion or a prize except for any liability which cannot be excluded by law.

20. If the Promoter is prevented from or delayed in performing an obligation by Force Majeure then the obligation is suspended during, but for no longer than, the period the Force Majeure continues and any further period that is reasonable in the circumstances. 'Force Majeure' means any event beyond the reasonable control of the Promoter, which occurs without the fault or negligence of the Promoter.
21. Subject to obtaining the approval from the regulator (if applicable), the Promoter reserves the right to delay or modify any aspect of this promotion if for any reason it is not capable or running as planned (including without limitation, by reason of infection by computer virus, bugs, tampering, fraud, technical failures, power failures or due to any other causes unforeseen or beyond the reasonable control of the Promoter which corrupt or affect the administration, security, fairness, integrity or proper conduct of the promotion) but only to the extent necessary to overcome the issue that is affecting the running of the promotion as planned.
22. By participating in the promotion, an entrant authorises the Promoter Group, and contractors and agents of the Promoter Group, to access, collect and use personal information about the entrant, and disclose personal information about the entrant, to the Promoter Group and its contractors and agents, for the purposes of (i) conducting the promotion; (ii) providing the entrant with information and marketing material about products and services of the Promoter Group; and (iii) making arrangements for a prize winner to be notified and receive their prize. Such information may be provided electronically, or by contacting the entrant by telephone or other means, until such time as the entrant asks the Promoter not to provide further information. The Promoter's Privacy Policy (available at www.ladbrokes.com.au/terms-and-conditions/) contains information about how to access, correct or make a complaint about the Promoter's handling of personal information. A prize winner may be asked by the Promoter to participate in publicity associated with the promotion. The prize winner will have the right to elect whether or not to participate in that publicity.
