## **GRNSW + Ladbrokes Million Dollar Chase Punters' Club**

### **Terms and Conditions**

1. The promoter is Ladbrokes Digital Australia Pty Ltd, 25 151 956 768, of 461-473 Lutwyche Road, Lutwyche Queensland, 4030, phone 1300 523 276 (**Promoter**). The Promoter and its related companies are referred to as the **Promoter Group**.
2. Instructions and information on how to enter the promotion form part of these terms and conditions, and entry into the promotion is deemed acceptance of these terms and conditions and all of the Promoter's terms and conditions.
3. Entry to the promotion is open from 3:00pm on 20 October 2018 until 8.00pm, or the advertised starting time of race two at Wentworth Park, Sydney (on 20 October 2018), whichever is the earliest (**Promotion Period**).
4. To enter the Promotion, an entrant must purchase a ticket during the Promotion Period. An entrant may purchase multiple tickets. Ticket purchase price is \$20 AUD.
5. Entry is open to residents of Australia who are 18 years of age or older.
6. The following people are not eligible to win any prizes resulting from this promotion:
  - a) directors, managers, agents, employees of the Promoter Group and their immediate families; and
  - b) directors, managers or employees of businesses associated with the promotion, including Wentworth Park Greyhounds and Greyhound Racing New South Wales.
7. The funds used to purchase tickets will be combined and distributed as follows:
  - a. 10% to be given as a charitable donation to the Greyhound Adoption Program NSW; and
  - b. 90% to be accessed by a representative of the Promoter (**Representative**). The Representative will use the remaining funds (**the Funds**) at his discretion to place bets on all races from race 3 at Wentworth Park Greyhounds Sydney (**Wentworth Park Greyhounds**) on 20 October 2018 onwards until the third last race of the meeting that day (**Betting Period**). Bets will be placed, at the discretion of the Representative, with oncourse bookmakers at Wentworth Park or with the totalisator operated by TAB Limited.

Neither the Promoter, nor the Representative will be entitled to deduct any amount from the Funds by way of commission, success fee, reimbursement of expenses or other form of compensation.

8. Each ticket purchased will guarantee the entrant a single and equal share in the Funds. Each entrant authorises the Representative to use their share of the Funds as specified in

clause 7(b) on their behalf. The Funds may change in value depending on whether the Representative uses the Funds to make winning or losing bets.

9. Notice of bets will be displayed prior to the running of each race in which bets are made during the Betting Period.
10. The Promoter's decision as to the result of the Promotion is final and no correspondence will be entered into.
11. The Promoter will attempt to notify all entrants of the outcome of the Promotion by the start time of the second last race on 20 October 2018 by announcing the dividend per share of the Funds at Wentworth Park Greyhounds, Sydney. The Promoter may also announce or publish the first name, surname and suburb or town of the prize winners in any media, including the Promoter's website and social media. Wentworth Park Greyhounds may also announce or publish the first name, surname and suburb or town of the prize winners on social media.
12. Upon the completion of the Betting Period, the Funds (if any remaining) will be distributed to each entrant in proportion to the number of tickets purchased, rounded down to the nearest dollar (if applicable). Entrants must present their ticket(s) to redeem a cash dividend equal to the final value of their share(s) in the Funds within one hour after the running of the last race of the meeting at Wentworth Park Greyhounds, Sydney on 20 October 2018 (**Cut Off Time**) otherwise their right to redeem their share of the Funds is extinguished. Any Funds remaining unredeemed after the Cut Off Time will be given as a charitable donation to the Greyhound Adoption Program NSW.
13. Should any portion of the Funds not be distributed as a result of rounding down the final value of each entrant's share to the nearest dollar, that portion of the Funds will be given as a charitable donation to the Greyhound Adoption Program NSW.
14. A ticket or the right to a ticket is not transferable or assignable to another person, or redeemable for cash otherwise than in accordance with these Terms and Conditions.
15. The Promoter reserves the right, at any time, to verify the validity of any entry or disqualify any entrant who submits an entry that is not in accordance with these terms and conditions or who tampers with the entry process. The decision to verify, validate or disqualify an entry is in the Promoter's absolute discretion.
16. If the Promoter reasonably considers that a change to these terms and conditions is likely to benefit entrants or be immaterial detriment to entrants, then the Promoter can make the change immediately and does not need to notify entrants. Alternatively, the Promoter may vary these terms and conditions by placing a notification at all places where these terms and conditions are made available to entrants.
17. No responsibility is accepted for late, lost or misdirected entries. The Promoter is not responsible for any problems or technical malfunction of any computer system, software or internet difficulties, including any damage to an entrant's device, resulting from participating in the promotion. Any cost associated with participating in the promotion are the entrant's responsibility.

18. None of the Promoter, the NSW Greyhound Breeders, Owners and Trainers' Association Ltd (trading as Wentworth Park Greyhounds) (**GBOTA**) or Greyhound Racing New South Wales will be liable for any loss or damage or personal injury suffered or sustained in relation to the Promotion or a prize except for any liability which cannot be excluded by law.
19. If the Promoter is prevented from or delayed in performing an obligation by Force Majeure then the obligation is suspended during, but for no longer than, the period the Force Majeure continues and any further period that is reasonable in the circumstances. 'Force Majeure' means any event beyond the reasonable control of the Promoter, which occurs without the fault or negligence of the Promoter.
20. Subject to obtaining the approval from the regulator (if applicable), the Promoter reserves the right to delay or modify any aspect of this promotion if for any reason it is not capable or running as planned (including without limitation, by reason of infection by computer virus, bugs, tampering, fraud, technical failures, power failures or due to any other causes unforeseen or beyond the reasonable control of the Promoter which corrupt or affect the administration, security, fairness, integrity or proper conduct of the promotion) but only to the extent necessary to overcome the issue that is affecting the running of the promotion as planned.
21. By participating in the promotion, an entrant authorises the Promoter Group, and contractors and agents of the Promoter Group, to access, collect and use personal information about the entrant, and disclose personal information about the entrant, to the Promoter Group and its contractors and agents, for the purposes of (i) conducting the promotion and (ii) providing the entrant with information about products and services of the Promoter Group. Such information may be provided electronically, or by contacting the entrant by telephone or other means, until such time as the entrant asks the Promoter not to provide further information. A prize winner may be asked by the Promoter to participate in publicity associated with the promotion. The prize winner will have the right to elect whether or not to participate in that publicity.

If an entrant does not provide the personal information requested, the entrant cannot participate in the promotion and will not receive information about products and services of the Promoter Group. 24. GBOTA has provided its consent and Greyhound Racing New South Wales has provided its written approval for this Punters' Club to be conducted in accordance with these Terms and Conditions.
