Million Dollar Chase Raffle

Terms and Conditions

1. The promoter is Ladbrokes Digital Australia Pty Ltd (ABN 25 151 956 768) of 461-473 Lutwyche Road, Lutwyche Queensland, 4030, phone 1300 523 276 (**Promoter**). The Promoter and its related companies are referred to as the **Promoter Group**.
2. Instructions and information on how to enter the raffle form part of these terms and conditions, and entry into the raffle is deemed acceptance of these terms and conditions and all of the Promoter's terms and conditions.
3. Entry to the raffle is free and automatic when an entrant provides to the Promoter their full name, phone number and email address upon entry. Each entrant will be allocated a unique raffle ticket upon entry, half of which will be kept by the entrant, and half to be placed into a barrel.
4. Entry to the raffle is open during the Million Dollar Chase Regional Qualifying Finals, which will take place on the following dates and at the following NSW greyhound tracks:
 - a. 10 September 2018 at Bathurst Greyhounds;
 - b. 11 September 2018 at Ladbrokes Park, Lismore;
 - c. 13 September 2018 at Maitland Greyhounds;
 - d. 14 September 2018 at Wagga & District Greyhound Club;
 - e. 15 September 2018 at Bulli Greyhound Racing Club;
 - f. 23 September 2018 at Dubbo Greyhound Racing Club;
 - g. 24 September 2018 at Temora Greyhounds;
 - h. 24 September 2018 at Shoalhaven Greyhound Racing Club;
 - i. 28 September 2018 at Richmond Race Club;
 - j. 28 September 2018 at Ladbrokes Gardens Greyhound Racing Club, Newcastle.
5. Entry is open to residents of Australia who are 18 years of age or older.
6. Entrants can only have a single entry in all of the Raffles.
7. Directors, managers, agents, employees of the Promoter Group and their immediate families are not eligible to win any prizes resulting from the Raffles.
8. The prizes for this Raffle are:
 - a. Accommodation for two people for the night of 20 October 2018 at a hotel in Sydney (location to be confirmed);
 - b. Two general admission tickets to the Million Dollar Chase Final, to take place at Wentworth Park in Sydney on 20 October 2018; and
 - c. \$500AUD spending money pre-loaded onto a Visa Card.

9. The retail value for each prize is \$770 AUD. The total retail value for all prizes is up to \$8,470 AUD.
10. The following conditions apply to the prize:
 - a. The prize does not include any insurance;
 - b. The items in clause 8 can only be used by people who are 18 years of age or older;
 - c. Some components have been pre-arranged, and others will be arranged when the identity of any winner has been determined;
 - d. The prize is subject to the Promoter's travel agent's terms and conditions (and the terms and conditions of the hotel, etc);
 - e. The reasonable requests of a winner will be considered, but not all requests will be possible due to factors including pricing and availability;
 - f. The prize is limited to the items listed in clause 8, and any additional costs or charges must be paid by the winner,
 - g. The winner must make all arrangements for receiving the right to the prize within 72 hours after we advise them that they have won;
 - h. If a prize (or a component of it) is not available for any reason, we reserve the right to substitute the prize with another of similar value, or at our discretion, with a cash sum equivalent to the retail value of that component of the prize, subject to state lottery laws; and
 - i. The right to any prize is not transferable or assignable to another person, and the prize is not redeemable for cash (other than in accordance the 10(h)).
11. The winning entries will be drawn from the barrel during each of the greyhound meets listed in clause 4. The first valid entry drawn will win the prize. The Promoter's decision as to the result of the prizes is final and no correspondence will be entered into.
12. The Promoter will attempt to notify the winners while at the location of the Raffles. If a prize winner is unable to be contacted during the relevant Raffle, that person's right to the prize is forfeited and the prize will be entered into an unclaimed prize draw. We may conduct such further draws at the same place and time as the original draw as are necessary in order to distribute any unclaimed prizes, as determined by us in our absolute discretion, subject to any directions given by a responsible authority under any relevant regulation.
13. The Promoter reserves the right, at any time, to verify the validity of any entry or disqualify any entrant who submits an entry that is not in accordance with these terms and conditions or who tampers with the entry process. The decision to verify, validate or disqualify an entry is in the Promoter's absolute discretion.
14. Subject to state lottery laws, if the Promoter reasonably considers that a change to these terms and conditions is likely to benefit entrants or be immaterial detriment to entrants, then the Promoter can make the change immediately and does not need to notify entrants. Alternatively, subject to state lottery laws, the Promoter may vary these terms and conditions by placing a notification at all places where these terms and conditions are made available to entrants.

15. The Promoter accepts no responsibility for late, lost or misdirected entries. The Promoter is not responsible for any problems or technical malfunction of any computer system, software or internet difficulties, including any damage to an entrant's device, resulting from participating in the raffle. Any cost associated with participating in the raffle are the entrant's responsibility.
16. The Promoter will not be liable for any loss or damage or personal injury suffered or sustained in relation to the raffle or a prize except for any liability which cannot be excluded by law.
17. If the Promoter is prevented from or delayed in performing an obligation by Force Majeure then the obligation is suspended during, but for no longer than, the period the Force Majeure continues and any further period that is reasonable in the circumstances. 'Force Majeure' means any event beyond the reasonable control of the Promoter, which occurs without the fault or negligence of the Promoter.
18. Subject to obtaining the approval from the regulator (if applicable), the Promoter reserves the right to delay or modify any aspect of this raffle if for any reason it is not capable or running as planned (including without limitation, by reason of infection by computer virus, bugs, tampering, fraud, technical failures, power failures or due to any other causes unforeseen or beyond the reasonable control of the Promoter which corrupt or affect the administration, security, fairness, integrity or proper conduct of the raffle) but only to the extent necessary to overcome the issue that is affecting the running of the raffle as planned.
19. By participating in the raffle, an entrant authorises the Promoter Group, and contractors and agents of the Promoter Group, to access, collect and use personal information about the entrant, and disclose personal information about the entrant, to the Promoter Group, its contractors and agents and the Newcastle Knights Football Club, for the purposes of (i) conducting the raffle, (ii) providing the entrant with information and marketing material about products and services of the Promoter Group and (iii) making arrangements for a prize winner to be notified and receive their prize. Such information may be provided electronically, or by contacting the entrant by telephone or other means, until such time as the entrant asks the Promoter not to provide further information. The Promoter's Privacy Policy (available at www.ladbrokes.com.au/terms-and-conditions/) contains information about how to access, correct or make a complaint about the Promoter's handling of personal information. A prize winner may be asked by the Promoter to participate in publicity associated with the raffle. The prize winner will have the right to elect whether or not to participate in that publicity.
20. If an entrant does not provide the personal information requested, the entrant cannot participate in the raffle and will not receive information about products and services of the Promoter Group. 21. All references to time in these terms and conditions are a reference to local Queensland time unless stated otherwise.
