Terms and Conditions

- 1. The promoter is Ladbrokes Digital Australia Pty Ltd (ABN 25 151 956 768) of 461-473 Lutwyche Road, Lutwyche Queensland, 4030, phone 1300 523 276 (**Promoter**). The Promoter and its related companies are referred to as the **Promoter Group**.
- 2. Instructions and information on how to enter the promotion form part of these terms and conditions, and entry into the promotion is deemed acceptance of these terms and conditions and all of the Promoter's terms and conditions.
- 3. Entry to the promotion is free and automatic when you register your details with the Ladbrokes' representatives at the Brisbane Bullets 2017 regular season home fixtures. The dates are as follows:

- 4. Entrants can only have one entry in the promotion.
- 5. Entry to the promotion is open from two (2) hours before tip-off on the date of each of the Bullets 2017 regular season home fixtures until tip-off for that same game (see table in clause 3 for details).
- 6. Entry is open to residents of Australia who are 18 years of age or older and who are in attendance at the relevant Game.
- 7. Directors, managers, agents, employees of the Promoter Group and their immediate families are not eligible to win any prizes resulting from this promotion.
- 8. The winning entry will be drawn randomly by computer at tip-off time at each Game and Location in clause 3.
- 9. The first valid entry drawn will win the chance to shoot for the prize (the "Contestant"). The Promoter's decision as to the result of the prizes is final and no correspondence will be entered into.
- 10. The Promoter will attempt notify the Contestant three times via telephone at quarter time in the Game.
- 11. If the Contestant is unable to be contacted after three telephone attempts, then that person's right to being the Contestant and winning the prize is forfeited and the Promoter will conduct such further draws at the same place as the original draws as are necessary at each Game and Location in order to select a contestant for the competition as determined by us in our absolute discretion, subject to any directions given by a responsible authority under any relevant legislation. In the event that a further draw is required, the Promoter will also attempt to notify the subsequent winning entry three times via telephone.

12. At three-quarter time in the Game, the Contestant will have five (5) attempts to shoot from various locations around the key. The first and fifth shot will be taken in front of the left and right block on the free throw lane, the second and forth shots will be taken at the top of the free throw lane and the third shot on the free throw line (see diagram below). Each successful shot is worth \$200, apart from the Brisbane Bullets v Sydney Kings Game on Thursday 15 February 2018, where each successful shot is worth \$400.



- 13. Once the Contestant has completed their five (5) attempts, if they were successful in at least one of them, they will be asked whether they want to attempt one shot for "double or nothing". They will be offered the choice to attempt one shot from the three-point line, and if successful will double their winnings of the first five (5) shots. If the three-point attempt is unsuccessful, the Contestant loses all their winnings from the first five (5) shots. If the Contestant elects not to take the three-point attempt, they win the winnings from their first five (5) shots.
- 14. Clause 13 does not apply to the Brisbane Bullets v Sydney Kings Game on Thursday 15 February 2018. Instead, once the Contestant has completed their five (5) attempts, if they were successful in at least one of them, they will be asked whether they want to attempt one shot for "double money". They will be offered the choice to attempt one shot from the three-point line, and if successful will double their winnings of the first five (5) shots. If the three-point attempt is unsuccessful, the Contestant will not lose any of their winnings from the first five (5) shots. If the Contestant elects not to take the three-point attempt, they win the winnings from their first five (5) shots.
- 15. If the Contestant is unsuccessful in all of their first five (5) attempts, they do not win any prize.
- 16. The prizes for the promotion are:
 - a. \$200 per successful shot (\$400 per successful shot during the Brisbane Bullets v Sydney Kings Game on Thursday 15 February 2018) (up to a maximum of five (5)

- successful shots) from locations as designated by Ladbrokes or Bullets employees (see clause 12) deposited into a Ladbrokes account; and
- b. Following the five (5) attempts, and in the scenario where at least one shot (out of the five) was successful, the contestant will have the opportunity to double their winnings with a successful shot from the three-point line. If successful, the amount won in the first five (5) shots (clause 16(a)) will be doubled. If unsuccessful, they will lose all their winnings from the first five (5) shots, apart from during the Brisbane Bullets v Sydney Kings Game on Thursday 15 February 2018, where if unsuccessful, they will not lose any of their winnings from the first five (5) shots.
- 17. The retail value for the prize is up to \$2000 and up to \$4000 during the Brisbane Bullets v Sydney Kings Game on Thursday 15 February 2018.
- 18. The following conditions apply to the prize:
 - a. The prize will be deposited to a Ladbrokes betting account in the winner's name within72 hours of Ladbrokes being provided with their account details;
 - b. The prize winners must do everything required of them to accept and take delivery of the prize within a reasonable period of time;
 - c. If the prize winner fails to comply with clause 18(b), their right to the prize will be forfeited and they will not be compensated in any way;
 - d. The items listed in clause 16 can only be used by people who are 18 years of age or older; and
 - e. If the prize (or a component of it) is not available for any reason, the Promoter reserves the right to substitute the prize with another of similar value, or at the Promoter's discretion, with a cash sum equivalent to the retail value of that component of the prize.
 - f. The right to the prize is not transferable or assignable to another person, or redeemable for cash (other than in accordance with clause 18(e).
- 19. The Promoter reserves the right, at any time, to verify the validity of any entry or disqualify any entrant who submits an entry that is not in accordance with these terms and conditions or who tampers with the entry process. The decision to verify, validate or disqualify an entry is in the Promoter's absolute discretion.
- 20. If the Promoter reasonably considers that a change to these terms and conditions is likely to benefit entrants or be immaterial detriment to entrants, then the Promoter can make the change immediately and does not need to notify entrants. Alternatively, the Promoter may vary these terms and conditions by placing a notification at all places where these terms and conditions are made available to entrants.
- 21. The Promoter is not responsible for any problems or technical malfunction of any computer system, software or internet difficulties, including any damage to an entrant's device, resulting from participating in the promotion. Any cost associated with participating in the promotion are the entrant's responsibility.

- 22. The Promoter will not be liable for any loss or damage or personal injury suffered or sustained in relation to the promotion or a prize except for any liability which cannot be excluded by law.
- 23. If the Promoter is prevented from or delayed in performing an obligation by Force Majeure then the obligation is suspended during, but for no longer than, the period the Force Majeure continues and any further period that is reasonable in the circumstances. 'Force Majeure' means any event beyond the reasonable control of the Promoter, which occurs without the fault or negligence of the Promoter.
- 24. Subject to obtaining the approval from the regulator (if applicable), the Promoter reserves the right to delay or modify any aspect of this promotion if for any reason it is not capable or running as planned (including without limitation, by reason of infection by computer virus, bugs, tampering, fraud, technical failures, power failures or due to any other causes unforeseen or beyond the reasonable control of the Promoter which corrupt or affect the administration, security, fairness, integrity or proper conduct of the promotion) but only to the extent necessary to overcome the issue that is affecting the running of the promotion as planned.
- 25. By participating in the promotion, an entrant authorises the Promoter Group, and contractors and agents of the Promoter Group, to access, collect and use personal information about the entrant, and disclose personal information about the entrant, to the Promoter Group and its contractors and agents, for the purposes of (i) conducting the promotion and (ii) providing the entrant with information and marketing material about products and services of the Promoter Group. Such information may be provided electronically, or by contacting the entrant by telephone or other means, until such time as the entrant asks the Promoter not to provide further information. The Promoter's Privacy Policy (available at www.ladbrokes.com.au/terms-and-conditions/) contains information about how to access, correct or make a complaint about the Promoter's handling of personal information. A prize winner may be asked by the Promoter to participate in publicity associated with the promotion. The prize winner will have the right to elect whether or not to participate in that publicity.
- 26. If an entrant does not provide the personal information requested, the entrant cannot participate in the promotion and will not receive information about products and services of the Promoter Group.
