CHARGES

DYLAN RIGBY and CRAIG DOUGLAS are charged as follows:

GAMING FACILITIES: DYLAN RIGBY

CHARGE 1

DYLAN RIGBY, between the 12th day of February 2015 and the 11th day of February 2016, provided facilities for gambling, namely gaming, when no operating licence had been granted under Part 5 of the Gambling Act 2005 which authorised such provision.

CONTRARY to section 33(1) of the Gambling Act 2005.

CHARGE 2 [ALTERNATIVE TO CHARGE 1, ABOVE]

DYLAN RIGBY was an officer of Game Gold Tradings Limited, a body corporate which committed an offence against section 33(1) of the Gambling Act 2005 in that between the 21st day of July 2015 and the 11th day of February 2016 it provided facilities for gambling, namely gaming, when no operating licence had been granted under Part 5 of the Gambling Act 2005 which authorised such provision; and that offence was committed with his consent or connivance or as a result of his negligence.

CONTRARY to section 33(1) and section 341 of the Gambling Act 2005.

CONTRARY to section 258 (1) of the Gambling Act 2005.

CHARGE 6 [ALTERNATIVE TO CHARGE 5, ABOVE]

DYLAN RIGBY was an officer of Game Gold Tradings Limited, a body corporate which committed an offence against section 258(1) of the Gambling Act 2005 in that, between the 21st day of July 2015 and the 11st day of February 2016 it promoted a lottery when no operating licence had been granted under Part 5 of the Gambling Act 2005 which authorised such activity; and that offence was committed with his consent or connivance or as a result of his negligence.

CONTRARY to section 25B(1) and section 341 of the Gambling Act 2005.

CHARGE 7 [ALTERNATIVE TO CHARGE 5, ABOVE]

CRAIG DOUGLAS was an officer of Game Gold Tradings Limited, a body corporate which committed an offence against section 258(1) of the Gambling Act 2005 in that between the 1st day of October 2015 and the 11th day of February 2016 it promoted a lottery when no operating licence had been granted under Part 5 of the Gambling Act 2005 which authorised such activity; and that offence was committed with his consent or connivance or as a result of his negligence.

CONTRARY to section 258(1) and section 341 of the Gambling Act 2005.

GAMING FACILITIES (FUTJACKPOT): DYLAN RIGBY (ALTERNATIVE CHARGES TO CHARGES 5&6, ABOVE)

CHARGE 8

ADVERTISING UNLAWFUL GAMBLING: DYLAN RIGBY AND CRAIG DOUGLAS

CHARGE 11

DYLAN RIGBY and CRAIG DOUGLAS, between the 1st day of June 2015 and the 11th day of February 2016, advertised unlawful gambling.

CONTRARY to section 330(1) of the Gambling Act 2005.

CHARGE 12 [ALTERNATIVE TO CHARGE 11, ABOVE]

DYLAN RIGBY was an officer of Game Gold Tradings Limited, a body corporate which committed an offence against section 330(1) of the Gambling Act 2005 in that between the 21st day of July 2015 and the 11st day of February 2016 it advertised unlawful gambling; and that offence was committed with his consent or connivance or as a result of his negligence.

CONTRARY to section 330(1) and section 341 of the Gambling Act 2005.

CHARGE 13 [ALTERNATIVE TO CHAR4GE 11, ABOVE]

CRAIG DOUGLAS was an officer of Game Gold Tradings Limited, a body corporate which committed an offence against section 330(1) of the Gambling Act 2005 in that between the 1st day of October 2015 and the 11th day of February 2016 it advertised unlawful gambling; and that offence was committed with his consent or connivance or as a result of his negligence.

CONTRARY to section 330(1) and section 341 of the Gambling Act 2005.
