I said I would send you a link to the [Quality Assurance of Administrative Data \(QAAD toolkit\)](#). This provides a useful framework for thinking about the quality of administrative data but is also applicable to other data sources.

Looking at the [Code of Practice for Statistics](#), I think you should look at pillar Q3: Assured quality which says the following:

- Q3.1 Statistics should be produced to a level of quality that meets users' needs. The strengths and limitations of the statistics and data should be considered in relation to different uses, and clearly explained alongside the statistics.
- Q3.2 Quality assurance arrangements should be proportionate to the nature of the quality issues and the importance of the statistics in serving the public good. Statistics producers should be transparent about the quality assurance approach taken throughout the preparation of the statistics. The risk and impact of quality issues on statistics and data should be minimised to an acceptable level for the intended uses.

So I think not doing the QA for the industry statistics would probably mean that the statistics don't get produced to a standard that meets users' needs. This should hopefully give you some reassurance for your discussions with your senior leadership.

Many thanks for your email and for your interest in our work on experimental statistics. Here's some background to the Office for Statistics Regulation's project that includes looking at the language around experimental statistics, as well as the reframing the designation of National Statistics.

We have been conducting a [review](#) about the designation to see how we can make it relevant and useful now. The UK Statistics Authority Board has approved our project to replace 'National Statistics' as a label put on official statistics to signify that OSR as the regulatory arm of the Authority has confirmed that the statistics meet the standards of the Code of Practice for Statistics.

The Statistics and Registration Service Act requires us to conduct assessments and confirm compliance with the Code – the legal term for confirmed statistics would remain ‘National Statistics’ but we can move away from using it publicly. Our [research](#) has shown that it is ambiguous and unclear. Instead we are moving to emphasise that the official statistics have been independently reviewed by the regulator and found to comply with the Code, showing trustworthiness, quality and value (our Code pillars).

I am planning our designation refresh project – a major part of it is to test the labels and explanations for the key concepts. We want to ensure that they are clear to the various audiences – both among producers and users.

You may be familiar with the [National Statistics logo](#) – it is put on all the statistics that we confirm comply with the Code. We have pondered about how to simplify the symbol, such as stripping it back to a simple tick to indicate the statistics that have been verified by OSR. We were wondering whether pop up messages would be helpful to say what the tick means and to have hyperlinks to our decisions.

As I mentioned above, other items to test include a new label for Experimental Statistics – we have a few suggestions so far. There are other short statements that we want to ensure are clear as well – a statement showing that producers are regulated (‘We are regulated by the Office for Statistics Regulation’), and there are some statements that we (OSR) need to use to explain our decisions. As well as clarifying the presentation of experimental statistics, the GSS is coincidentally also keen to develop guidance for statistics producers – OSR is including that development within our activities.

We would very much welcome your help with this project. I’d be very happy to arrange a time to talk through the project and to see how you feel you can contribute to the development.
