TERMS AND CONDITIONS:

I hereby make application to book a CMH Summer Adventures and Mountaineering (also referred to as CMH) trip, and I understand and agree to each and all of the following eight terms and conditions:

1. That **all rates and deposits are in Canadian funds**, and that **an allowance will be made for exchange if payment is in foreign currency**. Where applicable, rates are subject to change without notice to me.
2. That my initial deposit equal to 20% of my total trip cost (the "deposit"), for each trip that I am applying to book is **non-refundable**.
3. That full payments for all helicopter hiking or mountaineering trips are due and payable at the Banff office ten (10) weeks before the commencement date for all trips booked; and that in cases where these full payments are not received ten (10) weeks ahead of time, CMH reserves the right to release these spaces to persons on the waitlist. Further, that full payments for all helicopter hiking or mountaineering trips are deemed as deposits.
4. That in all cases of cancellation or change, an administration fee of \$75 (plus applicable taxes) will be charged. Further, **all cancellations must be received by telephone and confirmed in writing or by email** to CMH at its Banff address. If cancellation is received by CMH less than ten (10) weeks before the date of trip commencement and **if I can find a replacement** for the trip booked, any and all deposits will be transferred to my replacement. If cancellation is received by CMH less than ten (10) weeks before the date of the trip commencement and I cannot find a replacement for the trip booked, the total of all deposits for helicopter hiking or mountaineering trips will be retained by CMH. Deposits cannot be transferred to any other season.
5. That I will not be permitted to participate in any CMH Summer Adventure and Mountaineering trip unless a "CMH Summer Adventures and Mountaineering Waiver" in the form hereon is properly completed.
6. That it is my responsibility to arrive at CMH departure sites at the required times; and it is my responsibility for any extra costs incurred if I miss the scheduled CMH departures. It is also my responsibility to ensure proper entry through Canadian Customs and Immigration if entering from outside Canada. Refunds of payment made will not be given in cases where entry into Canada is denied.
7. That in the case that I am a prepayment holder, that my credit pursuant to my subscription **shall be treated in the same manner as a normal deposit**.
8. I understand that CMH reserves the right to take photographic or film records of any of its trips and hereby agree that CMH may use any such photographic or film records for promotional and/or commercial purposes, as well as approve such use by third parties with whom CMH may engage in joint marketing, without any remuneration to me. I hereby assign all right, title, and interest I may have in or to any and all media in which my name or likeness might be used by CMH.

By signing you are making a commitment. On the strength of this commitment, we will charter an expensive helicopter, stock food and helicopter fuel, provide vacation planning services, maintain a highly trained staff and turn away others who would like the space we are holding for you.

CMH SUMMER ADVENTURES AND MOUNTAINEERING WAIVER

WARNING: THIS AGREEMENT WILL AFFECT YOUR LEGAL RIGHTS. READ IT CAREFULLY!

In consideration of CMH (as defined below) accepting my application for and permitting me to participate in a helicopter hiking and /or mountaineering trip and/or other summer adventure experience (collectively referred to below as a "CMH Summer Adventures and Mountaineering Trip") on lands owned by or under the control of CMH or the Province (as defined below) or elsewhere, the following waiver of all claims, release from all liability, assumption of all risks, agreement not to sue and other terms of this agreement ("CMH Summer Adventures and Mountaineering Waiver") are entered into by me with and for the benefit of:

"Canadian Mountain Holidays LP" doing business as **CMH Summer Adventures" and Alpine Helicopters Inc.** and their parent companies, affiliates and subsidiaries (collectively, "CMH") and **Her Majesty the Queen in Right of the Province of British Columbia** ("Province") and the **"Personnel"** (as defined below).

I waive any and all claims that I have or may in the future have against, and release from all liability and agree not to sue, CMH, the Province and any of their shareholders, directors, officers, employees, servants, hiking, high adventure activities and mountaineering guides, helicopter pilots, helicopter maintenance personnel, agents, contractors, suppliers and representatives (collectively, the "Personnel") for any personal injury, death, property damage or other loss that I sustain during or as a result of any CMH Summer Adventures and Mountaineering Trip due to any cause whatsoever on the part of any one or more of CMH, the Province, the Personnel or others, including:

- (a) **negligence** (the meaning of which includes failure to use such care as a reasonably prudent and careful person would use under similar circumstances and failure to meet standards of care in the hiking, mountaineering and/or adventure industry in the Province of British Columbia for the safety of hikers, mountaineers and adventurers);
- (b) **breach of any other duty imposed by law**, including any duty imposed by occupiers liability or other legislation;
- (c) **breach of any contract**; and
- (d) **mistakes or errors in judgment** of any kind.

I am aware of the risks inherent in hiking, high adventure activities and mountaineering and I am aware that helicopter hiking, high adventure activities and mountaineering has certain additional dangers and risks, including but not limited to:

HIGH ADVENTURE ACTIVITIES: include zip lining, climbing via ferrata and ropes courses where clothing or hair becoming caught in harness, carabiner or pulley system and fear or anxiety associated with heights or participation in the high adventure activity.

AVALANCHES, ROCK FALL, ICE FALL: which can frequently occur in the mountain terrain used for hiking, high adventure activities and mountaineering and may be caused by man-made structures, including without limitation, towers, stairs, bridges, platforms or other landing systems, rock walls, cables, swings, zip lines or bridges, or by natural forces including steepness of slopes, snow or ice depth, instability of the snowpack or rock or glacier, or changing weather conditions, or by climbers, adventurers or hikers, or by aircraft or helicopter or the failure for any reason of CMH or its staff to predict whether the terrain is safe for hiking and mountaineering or where or when an avalanche, rock fall or ice fall may or may not occur;

MOUNTAINOUS AND STEEP TERRAIN: where a fall, whether roped or unroped, may cause injury or death. In addition, the mountainous areas used for hiking, high adventure activities and mountaineering have areas and steep slopes which in their natural state have many dangerous obstacles and hazards which may be hidden or covered by snow. Some of these obstacles and hazards include glacier crevasses, ice and snow cornices, tree wells, tree stumps, creeks, rocks and boulders, forest deadfall, holes and depressions, and varying and difficult snow and climbing conditions. These mountainous areas may also have dangerous man-made obstacles and hazards which may include rock walls, swings, zip lines, bridges, logging and other roads, steep road banks, fences and other structures. The areas used for hiking and mountaineering may not have been travelled previously and are not regularly patrolled or examined. Because of forested areas, wild and rugged terrain or bad weather, hikers, adventurers and mountaineers may become lost or separated from their guides or companions. Communication in this mountain terrain is always difficult and, in the event of an accident, rescue and medical treatment may not be available;

AIRCRAFT AND HELICOPTER TRAVEL: additional risks are posed by aircraft and helicopter travel in mountainous areas and in changeable weather conditions;

EQUIPMENT: equipment used for hiking, high adventure activities and mountaineering may fail. The equipment used may include, but is not limited to, swings, zip lines, pulleys, bridges, trolleys, tethers, cables, carabineers, ropes, helmets, harnesses, climbing protection, ice tools, skis, boots, ski poles, and avalanche transceivers. Equipment may be provided by CMH, its guides, or other hikers and climbers or it may be affixed to the mountain or trail;

WEATHER: weather conditions may be extreme and can change rapidly without warning;

ALTITUDE: the altitude of areas used for hiking and mountaineering may cause illness or death;

WILD ANIMALS: which are unpredictable in nature and may attack mountain travellers;

WATERCRAFT: I am aware of the risks of the use of any watercraft for transport or adventure. The risks may include, but are not limited to, frigid water, unpredictable currents, submerged rocks and rock outcroppings, fallen trees, waterfalls, sinking, capsizing, swamping, uncontrolled drifting, and collisions with other craft or obstacles. I acknowledge that there is as a significant risk of injury or death from these hazards, including by drowning or from hypothermia or delay in rescue.

LAKE AND FLY FISHING: I am aware that fishing in fast flowing rivers and streams, large and small lakes, either by wading or in boats or floatation equipment, can have unforeseen dangers and hazards including slipping and falling on rocks beneath the surface or being swept away in rapids or fast moving water; and I also am aware of the risk of drowning if I become submerged while wearing fishing waders.

TRANSPORTATION TO AND FROM AREAS: I am aware of the risks associated with transport through mountainous areas including rapidly changing road and highway conditions and the risks of using aircraft, motor coaches, vans and taxis which may or may not be owned and/or operated by CMH.

CMH, ITS STAFF AND OTHER HIKERS AND MOUNTAINEERS: the conduct, including negligence, of CMH, its staff including its guides and of all other hikers, adventurers and mountaineers whether they are associated with CMH or independent hikers, adventurers or mountaineers.

DRUGS AND ALCOHOL: I understand and agree that I will never board a helicopter, hike or participate in high-mountain adventures such as via ferratas while under the influence of alcohol or any drug, including marijuana, that could impair my ability to safely perform these activities, regardless of whether prescribed, legal or illegal, and I acknowledge that any failure on my part to comply will jeopardize the safety of myself and others and can result in my being not allowed to participate in the sole discretion of a guide.

I assume and accept all the risks and dangers of hiking, high adventure activities and mountaineering and the possibility of personal injury, death, property damage or other loss as a result. I agree that, although CMH and the Personnel may take precautions to reduce the risks and increase the safety of hiking and mountaineering and to determine whether a particular mountain is safe from the risk of avalanche or other hazards, it is not possible for CMH or the Personnel to make hiking, high adventure activities and mountaineering completely safe or to predict with complete assurance whether the terrain is safe. I willingly accept these risks and agree to the terms of this CMH Summer Adventures and Mountaineering Waiver even if CMH or any of the Personnel are found in law to be negligent or in breach of a duty of care or any other obligation to me in their conduct of any CMH Summer Adventures and Mountaineering Trip.

I am aware that the enjoyment and excitement of hiking, high adventure activities and mountaineering is derived in part from walking or climbing in wild, rugged, uncontrolled environments or climbing by man-made structures, including via ferrata, ropes, pulleys, zip lines, swings, bridges, and is contributed to by the inherent risks of hiking, high adventure activities and mountaineering.

In signing this CMH Summer Adventures and Mountaineering Waiver, I am not relying on any oral, written or visual statements of any kind, including promotional statements made by CMH in CMH Summer Adventures brochures or other brochures or by any of the Personnel or by the Province to induce me to go on a CMH Summer Adventures and Mountaineering Trip.

I confirm, as the parent/legal guardian of the minor participating in the helicopter ski trip, that the minor has the capacity of discernment (the meaning of which is the ability to fully understand a given situation and the consequences of one's actions). I confirm that I am of the full age of nineteen years, and that I have had sufficient time to read and understand what I am agreeing to in this CMH Summer Adventures and Mountaineering Waiver and have taken the time to ensure that the minor has read, understood and agreed to its terms before signing it. On my behalf and that of the minor, I agree that this CMH Summer Adventures and Mountaineering Waiver will be binding upon the minor, the minor's heirs, next of kin, executors, administrators and successors.

I agree that the CMH Summer Adventures and Mountaineering Waiver and the agreements it contains will be governed exclusively in all respects by and interpreted solely in accordance with the laws of the Province of British Columbia. I hereby irrevocably submit to the exclusive jurisdiction of the courts of the Province of British Columbia and I agree that no other courts can exercise jurisdiction over the agreements and claims referred to herein. Any litigation to enforce this agreement or arising out of my CMH Summer Adventures and Mountaineering Trip and/or other summer experience shall be instituted in the Province of British Columbia and nowhere else.

I agree that the terms "high adventure activities" "summer adventures" "helicopter mountaineering" "Heli-Mountaineering" "mountaineering" "Helicopter Hiking" "Heli-Hiking" and "Hiking" herein include rock climbing, climbing via ferrata or ropes, ziplining, walking, scrambling, ice climbing, skiing and other similar activities and the terms "mountaineer" "adventurer" and "hiker" includes zip liner, walker, scrambler, rock climber, ice climber, climber via ferrata or ropes and skier.

THIS AGREEMENT RELEASES CMH, THE PROVINCE AND ALPINE HELICOPTERS INC. FROM LIABILITY – PLEASE READ IT CAREFULLY.
