

# CMH English Minor eWaiver Guide

Thank you for taking the time to complete the CMH English Minor eWaiver for your child. The online waiver will take just a few minutes of your time, and will require two separate parents or guardians to complete.



## **Who needs a CMH minor waiver?**

Any child under 19 years old travelling with CMH is required to have a valid minor waiver completed on their behalf.



## Parent/Guardian Names and E-Mail Addresses

To begin, as the first parent or guardian, you must submit your name and email address, as well as the name and email address of a second parent or guardian. Once you have entered this information, you will be able to press the 'Begin Signing' button. An email will be sent to the second parent or guardian prompting them to sign the same waiver.

Once all required fields have been completed, the red box on the side will change from “Fill In” to “Finish.” You will have to press this button to confirm and complete the waiver process.




## Waiver Completed

A box will appear to let you know that “Your document has been signed.” At this stage you may choose to save your copy of the minor by clicking “Show Document” and following the prompts to save.



## Parent/Guardian 2 Signing Process

For the second parent or guardian, the process will be much the same. They will receive an email prompting them to review and sign the waiver for their child.





They will be required to fill in their own information, prompted by the boxes in red, and to adopt a signature in the same manner as Parent/Guardian 1.
