- Increasingly, payments are being returned and/or rejected due to incomplete addresses for 3rd party remitters. PO Boxes are not acceptable addresses; include the complete physical address to avoid processing delays. Please accept this as notice that this information will become mandatory.
- Occasionally, a specific currency requires an immediate change to its validation requirements (for example, non-mandatory information becomes mandatory with no/little notification). In such cases, Corpay is committed to sharing these changes via our trading platforms.
- If you receive an email request or an incoming phone call asking you to alter the banking information for one of your beneficiaries, contact them by phone, at the original number you have always used for that contact, to verify that banking information has actually been changed and you are not the subject of a phishing attempt.
- The allowable special characters are &,@,() but Corpay does not recommend special characters on payments as it can delay delivery.
