

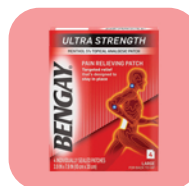
What is the Medicare Advantage OTC Allowance Benefit?

Most Medicare Advantage (also known as Part C) plans offer an OTC (over-the-counter) allowance benefit. The OTC allowance benefit provides eligible members with an allowance to pay for certain non-prescription items, plus health and wellness items.¹

Utilizing OTC Allowances

There are three ways Medicare Advantage providers may allow members to utilize OTC allowances.

Check your plan regarding OTC Allowances & product eligibility*

Catalog/Online, Phone, or Mail Order

Beneficiaries can peruse catalogs or websites with eligible products & place an order using a website, app, phone or mail.²

Receipt Reimbursement

After purchasing an eligible product, beneficiaries can submit their receipts for reimbursement.³

Debit Card at Retail

Beneficiaries use their OTC debit card & purchase eligible items in a separate transaction.
