Supported Living Credit

- 9. Summerset will give you a Supported Living Credit of \$235 each week towards your Services Agreement for the first year following settlement of your home (**Credit Period**), or any shorter period or less amount determined under clause 10 and 12 below if:
 - o you sign a sales application between 1 July 2025 and 31 July 2025 for any Serviced Apartment at Summerset Falls; and
 - o settlement is completed on or before 31 October 2025; and
 - o you enter and keep in place a Services Agreement with Summerset for care and domestic services.
- 10. In addition to the Supported Living Credit, it has been agreed between you and us that:
 - you will pay any portion of your Services Agreement fee which is not covered by the Supported Living Credit (including any additional services that you request or require, or any annual increases to the Services Agreement fee); and
 - o you will continue to pay the Services Agreement fee (including any additional services that you request or require, or any annual increases to the Services Agreement fee) applicable under your Services Agreement when the Credit Period ends.
