

# Pay for Performance

## Project Application

The Pay for Performance (P4P) program is intended to encourage implementation of energy efficiency measures by providing financial incentives tied to verified energy savings that are realized in the first year following implementation at the pre-approved site(s). The program is open to Institutional, Not-for-Profit, or Commercial (including multi-unit residential) facilities served directly or indirectly by Nova Scotia Power Inc. Incentives are based on a building's realized electrical energy performance verified at the meter and paid upon verification of at least a 10% reduction in electrical energy consumption.

Our Pay for Performance Program Guide provides detailed information about project eligibility and the process - from applying to the program and establishing a baseline to implementing your chosen electricity saving measures and conditions for incentive payment.
