FUND UNIVERSE

The fund may hold global equity securities, government, corporate and inflation-linked bonds, debentures, non-equity securities, convertible debt instruments, preference shares, money market instruments and assets in liquid form.

INVESTMENT OBJECTIVE

The Mazi Asset Management Prime Global Equity Fund is a global equity portfolio that seeks to provide long-term capital growth in excess of the benchmark.

INVESTMENT STRATEGY

The fund will seek to outperform the MSCI World All Country total return index over the medium-to-long term by owning a focused portfolio of high-quality, global, growth equities. The fund's equity exposure shall always exceed 80%. At any one time, at least 80% of the underlying portfolio will be comprised of global equity securities.

- Seek specialist Global equity exposure as part of their overall investment strategy;
- Believe long-term equity exposure adds value;
- Understand the nature of equity exposure in that there is a risk of market fluctuations.

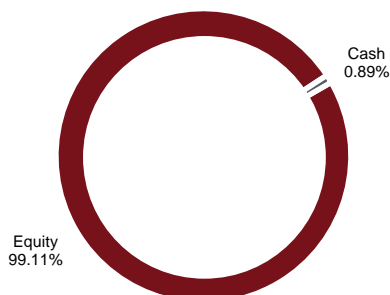

QUARTERLY COMMENTARY

Portfolio Comment

Our unhurried investment process leads to low portfolio turnover, a vital ingredient in long-term benchmark outperformance. Our portfolio turnover figures for 2021, 2022 and 2023 were 0%, 11.6% and 9.3% respectively. Investors can continue to expect low portfolio turnover from us. Notwithstanding, when the time comes to act, we do so decisively. During the quarter, we disposed of two businesses and acquired two new companies.

Forewarned in the previous Investor Note is foretold. We sold our old-timers Reckitt and Schindler. These remarkable businesses date from the 1800s with incredible everyday products and service franchises. Over many decades, they have become management-proof, unbreakable by grandiose acquisitions, impervious to carelessness, and produce plenty of excess cash profits year-in and year-out with a wide margin of operational safety. Yet, reaching for a structurally higher-growth trajectory is a bridge too far. Excess profits are not easily deployed into profitable growth-accelerating activities in their existing lines of business, but rather get distributed as dividends. Our mission is to seriously grow investor wealth over time. To do so, we require from our portfolio companies robust, sustained profitable growth that will meaningfully grow underlying shareholder value over time. These businesses, despite much to admire, struggle to move the dial that matters.

For a song we bought Melexis, a world leader in integrated automotive electronics. This Belgium-based company is largely unknown to the investment community. It is an asset-lite, deeply profitable business with high returns on invested capital (exceeding 35%) and prodigious cash flows that stands at the forefront of the design of electronic components for vehicles. In a no-growth global car park, its existing automotive business is expected to grow by at least 10% per annum for the next decade as traditional internal combustion engine vehicles consume ever greater quantities of silicone components and as nowadays electric vehicles embrace a whole new, integrated silicone and software design architecture for unified drivetrain, power, light, entertainment, and communication management. In addition to leading automotive technologies, Melexis' technology has application in robotics, healthcare, and other mobility technologies. This nascent business segment is expected to grow by at least 15% per annum. The future beckons.

In our Investor Note 2023 Q2, we flagged the potential disposal of Adobe on account of the pending \$20 billion acquisition of Figma, a subscale, profitless, collaborative web-design business with less than \$1 billion in annual revenue. In our view, the Figma takeover was fundamentally at odds with our investment philosophy and the rational capital allocation that we expect from our investee companies. The acquisition was subject to regulatory approvals in the US, Europe and the UK. It is with great relief that we report that the deal has indeed been abandoned by Adobe due to insurmountable regulatory obstacles. With the luxury of hindsight, the Figma deal was neither necessary nor important. We suspect that Adobe's management is quietly pleased with this regulatory outcome. Since the announcement of the acquisition, the ongoing developments in Adobe's own, very profitable, growing lines of business have been quite exciting, deserving 100% of management's time. Common sense, we hope, has prevailed.

Concluding Comments

We are optimistic about the long-term return prospects for our fund. We continue to find a number of long-term opportunities to investigate and pursue. As things stand, our portfolio companies are well set-up to grow profitably for many years to come. In the shorter term, falling long-term US interest rates bode well for valuations, likely to produce a handy tailwind for equity returns. Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

Specific Risk

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
