When training between 10 pm and 8 am, show extra consideration to neighbours and other people in the vicinity of the premises, i.e. talk in a "normal" conversational tone, do not drop weights or weight machines without following along in the movement.

I am aware that Fitness24Seven has a 2 month period of notice when cancelling a monthly paid subscription. Cancellation is made by the member via F24S homepage (www.fitness24seven.com) through the section "Omat sivut". Member will receive a confirmation of the cancellation via e-mail to the address registered in our system. The member is responsible for receiving and storing the confirmation and if necessary showing it to the F24S staff.

TERMS AND CONDITIONS FOR FITNESS24SEVEN OY MEMBERSHIP

§ 1. Membership

- Membership in F24S is personal.
- The minimum age for signing a membership agreement is 18 years of age.
- Training and conduct applies to all companies Fitness24Seven Oy, Fitness24Seven AB, Fitness24Seven-Lund AB, Fitness24Seven AS and Fitness24Seven Sp. z o.o.

Regular membership

- The regular membership gives access to all sites around the clock.
- Access through our disability entrances can be admitted upon registration in those facilities that have a disability entrance. The disability entrances can be accessed around the clock.

Other

- Pensioners and members with a valid pensioner card or certification from Kela are entitled to a pensioner discount for the entire membership period. Members with a disability pension are entitled to the pensioner discount for the validity period of their Kela certificate. After the expiry date of the certificate the discounted membership price will automatically be updated to the regular membership price. The disability pensioner discount can be continued upon presentation of a new valid Kela certificate. Price adjustments are not made in retrospective.

§ 2. Membership card and contact information

When visiting the site, members must register themselves on every occasion by swiping their membership card. Members are obliged to carry their membership card at all times during visits to the site, even while training; this is so it can be presented during the checks that are regularly carried out. If the membership card is lost or damaged so it cannot be used, this must be immediately reported to reception, which will then issue a new membership card in return for a payment of 9.90 €. Members are obliged to inform F24S immediately of changes of name, address, telephone number or other details provided.

§ 3. Payment

The agreed prices are valid on the condition that payment is made in the agreed manner. Members are liable personally for their payments to F24S. This also applies if someone else is marked as responsible for payment when registering for a membership. Both parties are required to sign an official Other Payer-form at the facility. The payment method of the Accident Insurance is defined by the type of F24S membership the member has. When choosing a membership (6 months or 12 months) that is paid entirely at once, will the Accident Insurance also be entirely charged in advance. Full time paid agreements will stop automatically after the term. In a continuous membership the Accident Insurance payments will also be paid monthly via e-invoicing.

Full year's payment

When signing up for a full-time paid agreement (6 months or 12 months) all the payments are paid in at once when registering for a membership.

E-invoice

When signing up for a continuous and monthly paid subscription the start-up fee and first month's fee is paid upon registration. After this the training fee is paid every month through e-invoicing.

Setting up the E-invoice permit

When signing up for an e-invoice membership it is the member's responsibility to activate the e-invoice permit in their personal online bank with F24S as the payee. Note that the customer's subscription does not end when the customer cancels his or her permit with the bank. Each customer must consult their own bank's instructions for setting up the e-invoice permit including general terms and conditions for the e-invoicing service.

Payment by E-invoicing

The membership is paid monthly with the same due date, the 29th of every month for the upcoming month's training time. The due date for the Accident Insurance is on the 1st of every month for the current month's insurance coverage. Members agree and commit to confirming the e-invoice monthly by its due date. Only private individuals are accepted as payers via e-invoice. Corporate accounts are not accepted. F24S demands the member to pay the monthly fee immediately and no later than the due date under threat of suspension until full payment has been made. F24S will surrender unpaid invoices to the debt collection company. In the case of member receiving a reminder or debt letter, must the payment be made according to the instructions given by the debt collection company. If the member disregards the instructions and makes the payment to F24S, can F24S redirect the payment to another payment, not to debt collection. F24S reserves the right to charge interest as per statute, administrative fees, reminder fees and debt collection costs in the case of late or non-payment. If a member is suspended because payment has not been made, this does not mean that the invoicing is frozen, the invoicing will continue normally. If a member pays an invoice that is overdue or chooses to pay in advance at the facility, F24S will charge a service fee of 5€. This is a separate service fee from any reminder or debt collection charges.

Smartum

Both F24S prepaid and e-invoice memberships can be paid in advance with Smartum Sport Coupons or Smartum Saldo card at the facility. When paying an e-invoice membership with Smartum coupons or card, F24S will charge a service fee of 5€. The minimum payment is for two months of training and the maximum for 12 months. E-invoices that have already been sent cannot be paid with Smartum coupons or card. No refunds are made.

Price adjustment under the current contracts

The price of a campaign subscription paid by e-invoice will automatically change to the current regular price after 12 months from the start date.

§ 4. Freezing or transferring the membership and the Accident Insurance agreement

It is possible to freeze membership without a fee in cases of illness or pregnancy with a medical certificate. Memberships can also be frozen free of charge due to army service with a call-up certificate. If the member wishes to freeze their subscription without a doctor's note, F24S will charge an admin/service fee. The membership agreement can be frozen for a maximum of 12 months per agreement period. After the frozen period runs out, the membership is automatically activated. It is not possible to freeze membership in retrospect. If the freezing is done in the middle of the invoicing period, it is mandatory to pay the sent invoice. Overpayment will be automatically compensated after the freezing period. Freezing and cancellation period cannot be simultaneously active. The freezing is done at the reception during opening hours. As the member I am responsible for receiving and storing the confirmation of my freezing and if necessary showing it to the F24S staff. Membership can be transferred once, i.e. the person taking over a membership cannot transfer it. When transferring a membership, the transferring member must pay a transfer fee of 30€ to F24S. The member taking over the membership must pay an administrative starting fee of 15 € and accept these terms and conditions in writing, which finally must be approved by F24S. The recipient of the transferred membership will also pay 9,90 EUR for a new membership card, if he or she does not own a membership card already. Monthly paid subscriptions, opening and campaign offers cannot be transferred.

§ 5. Cancellation of the membership and the Accident Insurance agreement

Cancellation is made by the member via F24S homepage (www.fitness24seven.com) through the section "Omat sivut". Member will receive a confirmation of the cancellation via e-mail to the address registered in our system. The member is responsible for receiving and storing the confirmation and if necessary showing it to the F24S staff. The cancellation period is 2 months from the day the member makes the cancellation and receives a confirmation. Invoicing is valid during the cancellation period. When cancelling the membership, the member must cancel the Accident Insurance as well, with the same two (2) month cancellation period. If the member wants to cancel only the Accident Insurance, must they choose the Accident Insurance separately when making the cancellation at the section "Omat sivut". In this case it is extremely important that the member chooses the cancellation for each product. Termination of the contracts are always binding and cannot be undone. The member's liability remains during the entire period of notice.

§ 6. State of health

Members are responsible for their own state of health being such that the member can participate in the activities at F24S without risk.

§ 7. Rules of conduct and training regulations

The premises are intended for activities related to training and may be used by members exclusively for training. For example, members may not sleep or in any other way sojourn on the premises. PT by F24S reserves the exclusive right to instruct and train our customers in our facilities. It is incumbent upon members to follow the rules of conduct and the instructions concerning training methods and use of equipment that are given, either in writing or verbally, by F24S's staff. Members are expected to behave at all times in a way that does not disturb other members or staff. If a member behaves disruptively or does not follow the rules of conduct and instructions, F24S has the right to limit the time the member may visit the site, the member's use of the site generally or may terminate the membership completely, upon which the member's liability to pay the 2 months' notice remains current. F24S reserves the right to terminate this agreement immediately without stating any reason.

§ 8. Guests

Members can bring one (1) guest per month to work out once, cost-free, within reception hours. The guest must be over 18 years old.

§ 9. Doping

Fitness24Seven reserves the right to interfere with all use of doping classed products in its facilities. In these cases Fitness24Seven reserves the right to suspend the member's subscription indefinitely according to § 7 in Fitness24Seven's contract terms.

§ 10. Liability for accidents and possessions

If a member has chosen to join the Accident Insurance, the member is insured during training at Fitness24Seven Oy facilities in Finland. The insurance is valid until the last validity date of the insurance subscription. The insurance provider is Lloyd's Insurance. F24S reserves the right to switch to another insurance provider without any changes in the conditions involving a significant deterioration of member. F24S is not responsible for personal injury, property damage or loss of any member's possessions unless the damage or loss is caused due to severe negligence by F24S.

§ 11. Price changes

An increase of price on continuing agreements shall be notified two months before the increase takes effect. Member who cancels his contract because of a price increase is protected against price change during the notice period.

§ 12. Personal Details

By means of automatic data processing, F24S stores personal details in a database complying with the provisions in the Personal Data Act. Members consent to F24S collecting and processing the personal details that are necessary for fulfilling this agreement. Members also give their consent for the personal details provided being used for the marketing of various goods and services. Entry when the site is not staffed takes place by means of fingerprint control. These details are stored solely on each individual membership card and it is these details that are compared with those read during entry. Members have been informed that the entry and the site are under camera surveillance for safety reasons.

§ 13. Identification

For a monthly paid subscription with E-invoice agreement a Finnish personal identity number, Finnish private account number and valid Finnish ID card are required. Full year's paid agreements require a valid ID card together with a Finnish work permit, residence permit or proof of application for asylum.

ADDITIONAL PARAGRAPHS ON PURCHASES VIA INTERNET

- §§ 14-16 only apply when members enter into a membership agreement via F24S's website.
- For purchases via the Internet, the Act on Distance Contracts is applicable.
- Purchases via Internet are personal in the meaning that it is only the individual who will become a member who can enter into the agreement via the website.
- Members have accepted via the website that the terms and conditions in this agreement apply for membership.

§ 14. Right of withdrawal

Members have the right within 14 days of the purchase to regret their purchase by notifying F24S. Member's membership is then terminated and he will get back the paid amount. The right applies provided that the membership card has not been collected at the site. Members may cancel their purchase via e-mail to info@f24s.fi.

§ 15. Payment

Payment of starting fees concerning the agreement is made through F24S's website in accordance with the instructions there. When entering into an agreement with monthly payments via e-invoice, it is the member's duty on entering into the agreement to report payment via e-invoice promptly via their Internet bank, with F24S as the payee.

§ 16. Terms of Delivery

The agreement comes into effect on the day the purchase is registered on the website, not the day when the card is collected. The member collects the membership card during the reception's opening hours at the facility stated in the Welcome email. The Welcome email is sent to the email address that was given during the purchase.

E-INVOICE

- §§ 17-18 only apply when members enter into a membership agreement with payment via e-invoice. It is easy to pay an e-invoice. The member receives the invoice that is to be paid directly to his/her Internet bank, the member checks and confirms it, and thus the payment is done. In the mandate for automatic payment, you can also establish the maximum amount that will be paid for invoices.

§ 17. E-invoicing

When signing up for e-invoicing membership, the member shall/will receive instructions to make attorney for e-invoicing in online bank from the member's personal bank account. The member must ensure that Fitness24Seven is activated as the payee at least 14 days before the first due date and that the e-invoice is accepted every month. During the subscription the customer agrees to pay the e-invoice monthly by the due date. The sender or the bank is not obliged to deliver an invoice to the member in any other form. The due date for our invoices are always the 29th of each month for the upcoming month. The member is responsible for all costs caused by the following: the training fee cannot be sent to the member's online bank due to lack of e-invoice attorney or erasing of the invoice or failure to confirm the invoice. Such costs include reminder fee and debt collection fees. Reminder letters and Debt Collection letters are sent by a Debt Collection Agency.

§ 18. Validity Period and Cancellation of the e-invoice permit

The agreement applies until further notice. The bank has the right with respect to the member to cancel the agreement with 2 months' notice by means of written notification to the customer, or via the Internet bank. The member has the right to cancel the agreement with the bank in writing or to terminate the service with immediate effect in the service's cancellation function. Despite the cancellation, the agreement is valid until the bank has reasonable time to terminate the service. Note that the member's agreement with respect to the payee does not end when the member cancels his or her agreement with the bank. Each member must consult his or her own bank's instructions for reporting E-invoicing and general terms and conditions for the e-invoicing service.
