- **4.** Capacity building: run training programmes for local guides, adventure-sports safety, event management, and basic coaching—prioritizing women and youth.
- 5. Carrying capacity and monitoring: mandate environmental impact assessments (EIA) and visitor management plans for event organizers and highuse sites.
- **6. Marketing and branding:** develop a "Green Sports & Eco-Tourism Maharashtra" brand with certification for sustainable operators, tied to digital marketing and responsible tourism platforms.
- **7. Linkages with health and education:** integrate school sports programmes with local eco-activities (e.g., annual nature sports week) to build conservation awareness.

## 10. Illustrative model: a community trail-race program (concept)

- **Site selection:** a low-impact trail near a village, with biodiversity and scenic value.
- **Community roles:** local cooperative runs registration, homestays, food stalls, and cultural events.
- Safeguards: limited participant slots, waste-free event rules, mandatory prerace briefings, and a portion of fees funding habitat restoration.
- Outcomes: short-term income, longer-term repeat visitors, youth employment as guides, and rising community interest in conservation.
