# **Meeting Minutes**

The meeting began at 2:10 p.m., with opening remarks from Board Chair Darryl Moore.

#### Land Acknowledgement

## Staff Introductions

Board Director Julie Phillips introduced the Downtown Kitchener BIA Staff: Linda Jutzi (Executive Director), Breanna Crossman (Marketing Manager), Lori Muller (Member Integration and Special Events), Stefanie Golling (Office Manager), and Alexandra Giovantto (Social Media Ambassador).

### Downtown Kitchener BIA Purpose and Overview

Linda Jutzi provided an overview of what a BIA is and why it exists, how levy payments are collected, and the importance of collaborating with partners and advocating on behalf of the membership.

#### Waterloo Regional Police Service

Linda Jutzi welcomed Cst. James Mitchell, and Cst. Lee Elliott to the meeting.

Jutzi acknowledged the difficulties people have had over the years. Because of the good relationship the BIA has with Waterloo Regional Police Service, they were able to bring back a dedicated officer to the core. Cst. James Mitchell noted that Jutzi has continuously advocated for dedicated officers in the core. Because of this, Cst. Matt Wilson has joined as a dedicated beat officer and has been making his way throughout downtown meeting businesses.

The meeting opened for questions, with no inquiry, Cst. Mitchell and Cst. Elliott encouraged members to reach out should they have any questions or concerns.

# Strategic Priorities – 2024 to 2027

Board Director Sarah Pearson shared an overview of the process taken to develop the new strategic priorities, noting that the BIA hired a third-party consultant, Shelley Aubry, as an unbiased person to ensure the Downtown Kitchener BIA reached various stakeholders and offered facilitated sessions to ensure representation with members, residents, office workers, and the Board of Directors.

Pearson shared the new Mission, Vision and 2024 to 2027 Strategic Priorities with the group:

**Mission:** to make Downtown Kitchener a destination where people connect with each other, businesses and culture.

**Vision:** the Downtown Kitchener BIA is driven to activate, beautify and connect a thriving community that fosters innovation, inclusivity and vibrancy.

#### Core Values:

- Local and Unique: uplifting the small businesses and restaurants that operate independently, creating a local and unique experience for all those that visit.
- Community-centric: continue to foster Downtown Kitchener as a neighbourhood that feels like home, whether that means bumping into friends on the street, in a business, or at a local festival/event.

### 2024 to 2027 Strategic Priorities:

- Activate: promote authentic experiences; support a vibrant arts and culture scene; amplify the use of live entertainment; and encourage experiences in unique spaces.
- Enhance & Beautify: engage in programs to make Downtown attractive for visitors, employees, and residents; work with partners where possible, including municipal and regional governments, for the best return on investment in all beautification efforts.
- Connect: act as the catalyst connecting people to the Downtown district; focus on making new connections between residents, businesses and community events.

## City of Kitchener

Manager of Downtown Economic Development Darren Becks shared an overview of their 2023 focus, highlighting the Gaukel Block, Carl Zehr Square, DTK Visioning exercise, and supporting operational efforts. Becks noted that over the last three years, the dedicated Downtown Operations team and Economic Development have concentrated on cleanliness, horticulture, the façade grant and the patio program process.

In 2024 and beyond, once they receive approval to work on an action plan for Downtown, they will focus on activation and placemaking initiatives on the Gaukel Block, relaunching the façade grant, and streamlining the permit and licensing process to support downtown business.

Becks reminded members that if they require support, whether navigating events, the 220 Popup space, or façade grant applications, feel free to reach out. Should members need help with operational concerns, they should call the Corporate Contact Centre or complete an online report, as it will ensure faster service.

Special Events Manager Steve Roth shared that he is new to the role and has spent the last six months listening, watching, learning, and building partnerships to collaborate and explore opportunities. The Special Events portfolio is growing, diversifying, and will include exciting changes, including the Christkindl Market. Roth noted that this year's event will look different, but in a good way.

At the recent Wayback Festival, Special Events collected data showing that 17,000 people attended. Roth shared that he wants to take that information and build on it to make the data advantageous to everyone.

# Financial Manangement

Board Director Michael Rederer explained the process taken to ensure the funds of the BIA are managed appropriately under the review of the Finance Committee, Board of Directors and city-appointed auditor – KPMG. When developing the budget, the Board of Directors reviews each line item to understand how the spending will benefit the membership.

# Proposed 2024 Operating Budget

Linda Jutzi provided an overview of the proposed 2024 Operating Budget, highlighting that all new budget line items fall under one of the new priorities: Beautify/Enhance, Activate and Connect. Additionally, Jutzi announced a new staff position that will connect to entertainment and businesses.

#### Membership Questions

The following questions, comments and discussions happened during the meeting:

- Clarification on the Holiday Window Decorating program.
- How to connect businesses with events.
- The group discussed the data collection during the Wayback Festival and how it is quantified. Members expressed that they would love access to the data collected.
- It's great to see weekend events; however, it is dead during the week. When will the City of Kitchener staff come back to the office? We need them back it creates vibrancy and energy. Leaders need to lead by example and support where they live and get paid from, or this will become an unsafe and desolate place.
- Downtown Dollars have always been advantageous; however, usage is down. It appears businesses are turning them down and not understanding how they work.
- Clarification on the vision for the arts and culture activation and how the new role will connect to this budget.

- Clarification on the increase to the levy.
- How does the Live Entertainment grant work for members?

# **Closing Remarks**

Linda Jutzi expressed that it is an honour to work with this membership. Board Chair Darryl Moore thanked everyone for their participation.
