CANFER Declaration of Certification

Dear Metrie Customer,

The Formaldehyde Emission from Composite Wood Products Regulation (CANFER) has been in effect since January 2023. CANFER is a Canadian federal regulation under the Canadian Environmental Protection Act, 1999. CANFER applies to any Composite Wood Product (CWP), component parts or finished goods containing CWPs, that are sold, supplied, offered for sale, manufactured, or imported into Canada.

The purpose of the regulation is to establish limits for formaldehyde emissions from CWP to avoid harmful health effects.

CANFER is written to mirror the Toxic Substances Control Act (TSCA Title VI), established by the US Environmental Protection Agency.

Consistent with CANFER requirements, we are offering this Declaration of Certification (DOC) for products that we manufacture, import, distribute and/ or sell in Canada.

We will update the DOC as required to provide accurate information.
