Stockport Local Development Scheme – November 2021

Introduction

The Planning and Compulsory Purchase Act 2004 requires Councils to prepare and maintain a Local Development Scheme (LDS). The purpose of the Local Development Scheme (LDS) is to inform the public about the current planning policies for Stockport and set out the programme for the preparation of the Local Plan. When preparing new planning policies or policy documents the Council must do so in accordance with the timetable set out in its LDS. This lets stakeholders and the community see when they can become involved in the production of planning documents, in particular, when there will be periods of consultation.

Possible effect of the Planning White Paper – Planning for the Future

In August/September 2020 the Government consulted on a document setting out the potential future for planning in England. That paper set out fundamental changes to the planning system, including proposing significant changes to how local plans will be prepared in the future. Advice from the Department for Levelling Up, Housing and Communities, however, is clear that councils should continue to work on developing plans as quickly as possible under the current system. There is no clear indication of when new legislation and regulations might come into force, nor what those would contain. The LDS has therefore been compiled and published in the light of that advice.

Current adopted Development Plan Documents for Stockport

The current Development Plan Documents for Stockport are the following adopted DPDs in addition to remaining 'saved' UDP Proposals Map.

Stockport Core Strategy (March 2011). This sets the overall spatial strategy and vision for the borough, establishing the broad aims and objectives for the use of land. <u>https://www.stockport.gov.uk/development-plan</u>.

Greater Manchester Joint Waste Development Plan (April 2012). This identifies sites required to meet Greater Manchester's future waste management needs and development management policies to enable effective and appropriate development of those sites.

Greater Manchester Joint Minerals Development Plan (April 2013). This shows how Greater Manchester's Local Planning Authorities, including Stockport, will meet the identified needs for minerals within acceptable social, economic and environmental parameters. https://www.greatermanchester-ca.gov.uk/media/1995/the minerals plan april 2013 final.pdf.

Supplementary Planning Documents (SPD) and Supplementary Planning Guidance (SPG) are currently available to provide guidance on the implementation of the policies of the Local Plan. SPDs and SPGs are adopted by the Council following public consultation. SPDs and SPGs are not part of the statutory Development Plan but are a material consideration in determining planning applications.

Statement of Community Involvement (SCI) sets the standard and approach to involving stakeholders and the community in the preparation of all development plan documents and the determination of planning

New Development Plan Documents Under Preparation

The Stockport Local Plan will replace the Stockport Core Strategy (March 2011) and the remaining 'saved' policies of the Stockport Unitary Development Plan Review (May 2006).

The Stockport Local Plan will provide the overall spatial vision and framework for the future sustainable development of the borough. It will address needs and opportunities in relation to housing, the economy, community facilities and infrastructure. It will also provide a basis for safeguarding the environment, adapting to climate change and securing good design. The Stockport Local Plan will, via the Policies Map (below) set out broad locations and specific allocations of land for different purposes. The plan's designations will show areas where particular opportunities or considerations apply (such as protected habitats). The Local Plan will set out criteria-based policies which will form the primary consideration in the determination of planning applications.

The emerging Local Plan will have an accompanying Policies Map. The Policies Map itself has the same status as a Development Plan Document (DPD) showing the land allocations and designations from other DPDs in map form. It will replace the current Proposals Map which was adopted with the UDP Review (2006) and amended by the Greater Manchester Joint Minerals and Joint Waste plans. In preparing and adopting any new DPDs the Council will have regard to whether amendments or additions to the Policies Map are required.

The Localism Act (2011) introduced new rights and powers to enable communities to get directly involved in planning for their areas. Neighbourhood planning allows communities to come together through a parish council or formal neighbourhood forum and produce a neighbourhood plan. Neighbourhoods can decide what they want to cover in their neighbourhood plan. They may allocate land for development or influence the type and design of development that comes forward. Neighbourhood plans must, however, be in general conformity with the strategic planning policies already adopted by the Council. They should not promote less development than set out in the Local Plan and or undermine its strategic policies. They are subject to an independent examination and need to be approved by a majority vote in a local referendum.

Once plans are adopted they will become part of the Development Plan and be used in the determination of planning applications. To date, Stockport Council has formally designated four neighbourhood areas (where plans are being led by neighbourhood forums). Two of these, Woodford and High Lane Village, now have adopted Neighbourhood Plans. The neighbourhood areas are:

Sustainability Appraisal (SA), Strategic Environmental Assessment (SEA) and Habitats Regulations Assessment (HRA)

The Council adopts an integrated approach towards Sustainability Appraisal and the requirements for all development plan documents to be subject to a Strategic Environmental Assessment (SEA) and a Habitats Regulations Assessment (HRA). This ensures compliance with relevant regulations, ensuring efficient working and to providing a robust and transparent evidence base.

The Sustainability Appraisal (SA), SEA and HRA will be embedded into the production of all LDDs as part of the initiation / evidence-gathering stage. Appraisals will then be updated at other appropriate milestone stages.

As part of the processes for the above the Council will:

- Prepare an SA (including an SEA) to appraise the social, environmental and economic effects of plan strategies and policies, from the outset of the preparation process;
- Prepare an Equalities Impact Assessment (EqIA) in line with relevant legislation.
- Prepare an HRA in line with relevant legislation.
- Include the draft SA/SEA, HRA and EqIA documents within the public consultation on each DPD and SPD where required.

The Council also undertakes Health Impact Assessment and other non-statutory forms of assessment as appropriate when preparing or updating policy and strategy documents. This might include, for example, rural-proofing or age-proofing exercises.
