## **Help with Rent and Council Tax for Students**

## Students and Benefits

Some students can claim Housing Benefit (Help with their Rent) and Council Tax Support (Help with their Council Tax).

If you are a member of a couple and your partner is **not** a student, then you can claim Housing Benefit and Council Tax Support using your **joint** income and circumstances.

In all other cases, a full-time student, or a couple, both members of which are students, will only be able to claim benefit if they are :-

- Responsible for a dependent child or children.
- A pensioner.
- Getting Income Support, Income based Job Seeker's Allowance.
- Disabled.
- Aged under 21 where the course of study is **not** higher education and the course started before the age of 19.
- Aged under 20 on approved training which started before the age of 19

However, not all students can get Housing Benefit or Council Tax Support.

Students who live in an educational establishment (e.g. Halls of Residence) will not be able to claim.
