STOCKPORT MUSIC SERVICE INSTRUMENTAL HIRE AGREEMENT 2017-2018

- Hire of a SMS instrument is ONLY available if your son/daughter will be having instrumental lessons with a Music Service tutor. If you are unsure (e.g. if changing schools) then please contact the office. Instrumental hire is also dependent on a suitable instrument being available.
- For 2017-18, the cost of the annual hire for all pupils will be £60. This can be paid in full with this application, or there is an option to pay in two instalments of £30.00: one with this application and the other to be invoiced at the end of October 2017. You will also receive a complementary music bag, pen, pencil and notepad, which can be collected with your instrument from the Music Service.
- If you start your hire part way through the year, a pro rata reduction will be applied. There is a remission available for
 families in genuine financial hardship and this should be discussed with the Music Service if you feel you may
 qualify.
- Alternatively you may wish to purchase an instrument through the Assisted Instrument Purchase Scheme. This scheme enables the Music Service to buy an instrument on your behalf, exempt from VAT. This saving, coupled with the discounts given to us by suppliers enables you to buy an instrument at a much lower price than would otherwise be possible.
