

Your Council Tax explained 2022/23

Your Council Tax money goes towards local services such as support for the elderly and vulnerable, for young people and schools, parks maintenance, refuse disposal, street cleaning and many more local services.

Each property in Stockport pays Council Tax, the amount charged depends on the Government's banding of your property which is determined by the property's value.

In Stockport, the Council Tax charges are as follows.

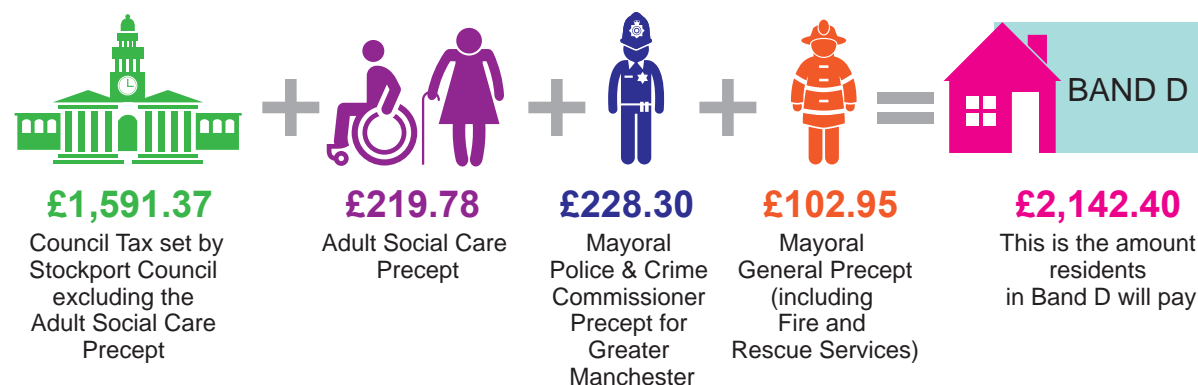

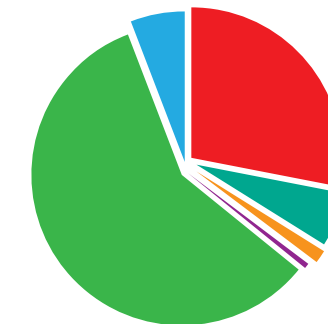

Adult Social Care

The cost of adult social care is increasing due to the financial impact of the pandemic, inflationary costs and increasing demand on services which support our elderly and vulnerable residents. As a provider of adult social care services Stockport Council is allowed, by Central Government, to include an Adult Social Care Precept on Council Tax Bills. For 2022/23 this Precept will increase by 2.5% raising additional income to support the funding of the increasing costs of providing adult social care services.

Cost of Living Rebate

The Council will issue a £15 one off cost of living rebate to all A to D band households in 2022/23. The rebate is to support households with increasing costs of living such as food and energy cost increases. This is in addition to the Government's £150 energy rebate to all A to D households
