

## **Notice of Designation of High Lane Village Neighbourhood Forum**

### **Decision**

Notice is hereby given that Stockport Metropolitan Borough Council, pursuant to a decision made on 14<sup>th</sup> September 2017 by the full council, has designated the Neighbourhood Forum as applied for by the provisional Neighbourhood Forum, relating to the designated High Lane Village Neighbourhood Area, under the provisions of the Localism Act 2011. The boundary of the designated area is available to view at [www.stockport.gov.uk/neighbourhoodplans](http://www.stockport.gov.uk/neighbourhoodplans). The Neighbourhood Forum are thereby empowered to undertake Neighbourhood Planning activities within the designated High Lane Village Neighbourhood Area.

According to the Town and Country Planning Act 1990 Act 61F (8) (as amended), the forum designation expires five years from the day on which it was made, this does not affect the validity of any proposal for a Neighbourhood Plan made before the end of the period. The Planning Authority can also withdraw the designation sooner than the five years if it considers the Neighbourhood Forum is no longer meeting its aims or satisfying the criteria for designation.

Reasons for the decision:

- The necessary publicity has been under taken on the proposed Neighbourhood Forum.
- The proposals, as submitted, meet the legislative requirements, particularly the conditions contained in section 61F(5) of the 1990 Act.

Further information regarding the application, the consultation undertaken on it and the factual and policy considerations which are of relevance to its determination is available in the report to the Council which sought their decision.
