

THE METROPOLITAN BOROUGH COUNCIL OF STOCKPORT
(FOOTPATHS 105 AND 96 CHEADLE AND GATLEY) (TEMPORARY CLOSURE)
ORDER 2022

WHEREAS the Metropolitan Borough Council of Stockport ("the Council") being the Traffic Authority for Public Footpaths 105 and 96 Cheadle and Gatley is satisfied that traffic on the said footpaths should be restricted in order to allow necessary works to be completed by contractors acting for Network Rail.

NOW THEREFORE, the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, hereby makes the following Order:-

1. There will be a temporary closure of Footpath 105 Cheadle and Gatley running north west to south east between 131 and 133 Heathbank Road crossing the Railway line and entering fields adjacent too Cheadle Hulme School and running until meeting Footpath 98 Cheadle and Gatley.

Footpath 96 Cheadle and Gatley running North East South West from 130 Heathbank Road to 35 Three Acres Lane
whilst traffic signs to that effect are in place on or near the said footpath.

2. It is anticipated that the maximum duration of the works will be 6 months .
3. An alternative route will be provided via: Heathbank Road 130 to Dawlish Avenue, Crossing to path alongside 1 Dawlish avenue and exiting against 25 Lawnhurst Close. Following Lawnhurst Close to 2 Lawnhurst Close and using the path through the play area to access Three Acres Lane and following the lane until the path between number 37 and 33 where Footpath 96 Cheadle and Gatley can be re-joined.
4. This order shall continue in force:
 - (a) for a period of 6 months from 25 February 2022; or
 - (b) for such a further period as the Secretary of State for Transport shall approve.
5. This Order shall come into operation on the 25 February 2022 and may be cited as The Metropolitan Borough Council of Stockport (Footpaths 105 and 96 Cheadle and Gatley) (Temporary Closure) Order 2022.
