

Policy Terms and Definitions

POLICY TERMS

The following terms apply to all OMERS policies and guidelines:

1. **Access to Policies** - OMERS policies and guidelines are available to employees and Directors through the SharePoint site or Compliance & Ethics. Certain policies are also posted externally on www.omers.com.
2. **Compliance with Policies** - Employees are accountable for understanding and complying with the policies and procedures that apply to them, including any amendments, as a condition of their ongoing employment.
3. **Review and Updating** - Policies and guidelines must be reviewed on a periodic basis and amended to reflect any external or internal changes that impact how these documents are applied.
4. **Mandatory, Recommended and Discretionary Language**

Where a policy uses the word “must” or “will” or “shall”, the course of action is mandatory. A different course of action may only be authorized if the applicable Policy permits exceptions.

Where the word “should” is used, the course of action is recommended.

The word “may” is an enabling term and the course of action is discretionary unless it is used together with “not”, in which case the phrase “may not” refers to a mandatory prohibition.

Designated Contractor	<p>an individual paid through invoice who has been designated by the hiring manager, in consultation with Compliance, as in scope for OMERS Code of Conduct and Ethics and/or other OMERS policies and related requirements. Application of these policies must be included in the terms of the contracting agreement and communicated to the Compliance & Ethics team so that appropriate controls may be implemented.</p> <p>Designated Contractors may be individuals hired for a specific period to complete a project, provide subject matter expertise or otherwise fulfill an assignment under the supervision of an OMERS employee. Consideration is given on a case-by-case basis to determine if an individual is a Designated Contractor. The criteria for this consideration includes but is not limited to:</p> <ul style="list-style-type: none"> nature and duration of the assignment;

	<ul style="list-style-type: none"> • nature and sensitivity of the information needed to perform the assignment; • access to corporate premises; • assignment of a corporate device and/or corporate email account; and • regulatory or oversight requirements for the applicable jurisdiction of work. <p>Once confirmed as such, Designated Contractors are subject to the same training and reporting requirements as employees unless specific exclusions are identified and communicated to the individual in writing.</p>
