

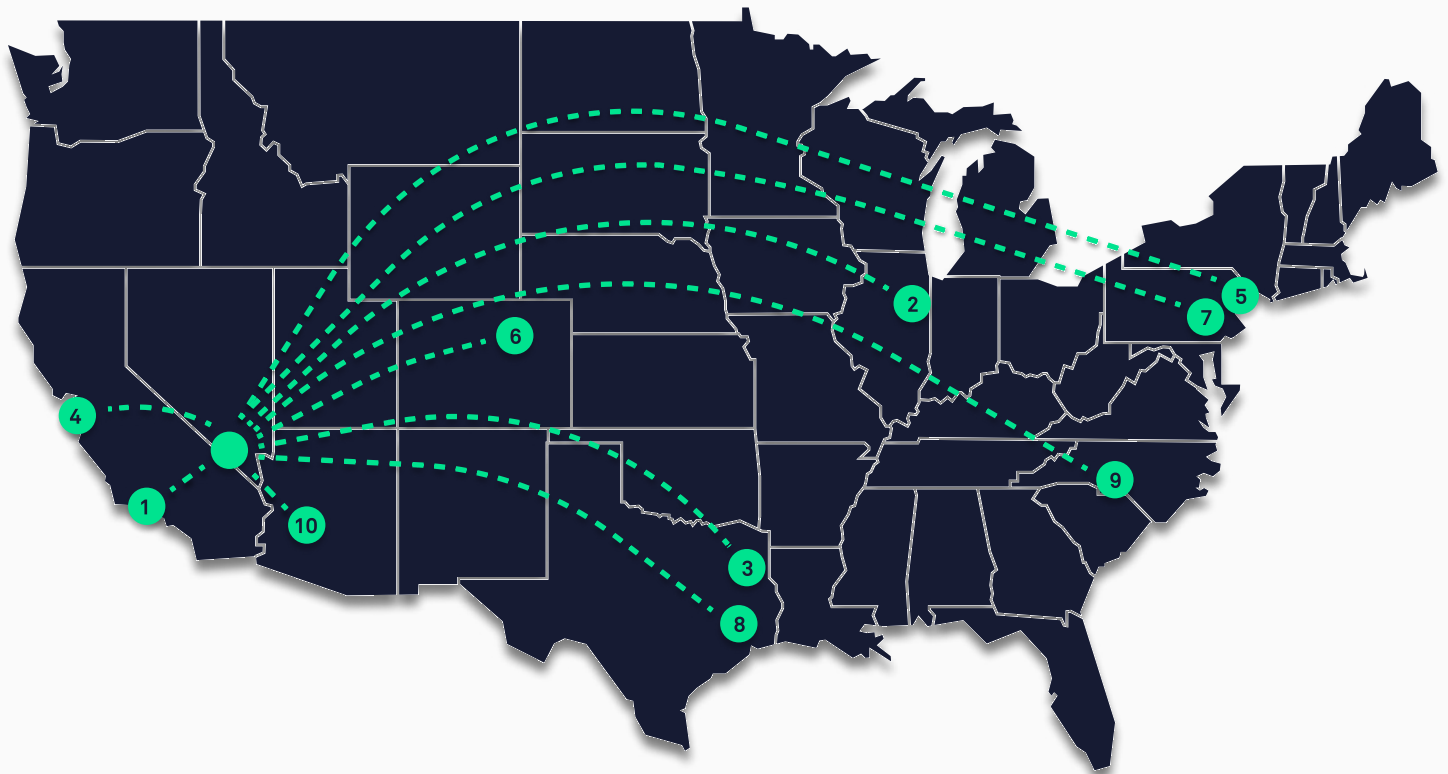
Top 10 most popular US domestic routes to/from Las Vegas this autumn

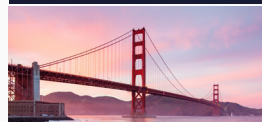

All of this quarter's Top 10 routes apart from San Francisco <> Las Vegas had already surpassed 3Q19 passenger revenue by mid-September, driven by higher fares. Phoenix is the only new entrant on the list - leap-frogging Seattle and Boston - with ticket revenues that are almost 3x the 2019 level.

Summary of US regional trends for 3Q22-1Q23:

- Domestic US business class traffic is ~20% higher than pre-pandemic levels;
- High demand in earlier booking windows suggest that this may be driven by leisure traffic as well as returning corporate travel.
- NA-NA yields and volumes for Q3 are up 33% and 15% respectively, and Q4, up 28% and 42%.
