Below we inform about the collection of personal data when subscribing to our newsletter. Personal data is all data that relates to you personally (for example: name, address, e-mail addresses, phone number etc.).

- 1. Responsible referred to Article 4 paragraph 7 GDPR is TEXAID Textilverwertungs-AG, Militärstrasse 1, 6467 Schattdorf, phone +41 41 874 54 00, fax +41 41 874 54 01, info@texaid.ch. The company data protection officer of TEXAID Textilverwertungs-AG can be contacted at the above-mentioned address or at datenschutz@texaid.ch.
- 2. With your agreement, you can subscribe to our newsletter, which informs you about our current interesting offers.
- 3. To our newsletter you register with the so-called double-opt-in-procedure. This means that after you have registered, you will receive an e-mail to the e-mail address you have provided in which we ask you to confirm that you wish to receive the newsletter. In addition, we store your IP addresses and times of registration and confirmation. The purpose of the procedure is to prove your registration and to be able to clarify if any possible misuse of your personal data happens.
- 4. The only requirement for sending the newsletter is your e-mail address and language. After your confirmation, we will save your e-mail address for the purpose of sending you the newsletter. The legal basis for this is Article 6 paragraph 1 sentence 1 letter a of the GDPR.
- 5. You can revoke your agreement to the sending of the newsletter at any time and unsubscribe from the newsletter. You can cancel this by clicking on the link provided in every newsletter. The legality of the data processing carried out based on the agreement until the revocation remains unaffected by the revocation.
- 6. The data are collected exclusively pseudonymised, so the IDs are not linked to your other personal data, a direct personal reference is excluded.
 - You can object to this tracking at any time by clicking on the separate link that each newsletter contains. The information will be stored as long as you have subscribed to the newsletter. After deregistration, we store the data purely statistically and anonymously.
- 7. In part, we use external service providers based in the European Economic Area to process your data. These service providers were carefully selected by us, commissioned in writing and are bound by our instructions. They are regularly checked by us. The service providers will not pass on these data to third parties, but delete them after fulfillment of the contract and the conclusion of legal storage periods, as far as you have not consented to an additional storage.

- 8. You have the right to request information from us at any time about your personal data stored with us (Article 15 GDPR). This concerns the purpose of the storage and also the recipients or categories of recipients to whom this data is shared. In addition, you have the right to demand the rectification and / or, under the conditions of Article 17 of the GDPR, of the deletion and / or, under the conditions of Article 18 of the GDPR, the restriction of processing under the provisions of Article 16 of the GDPR. Furthermore, under the conditions of Article 20 GDPR, you can request data transfer at any time, provided the data is still stored by us.
 - Under the conditions of Article 21 paragraph 1 of the GDPR, data processing can be objected to, for reasons arising from the particular situation of the person concerned.
