Summary of key changes incorporated into LCCP July 2016

October 2016

Introduction

- 1 This document summarises the key changes to the *Licence conditions and codes of practice* (LCCP) that we have consolidated into the LCCP July 2016 following the Gambling Commission's consultations on:
 - The prevention of crime associated with gambling: Amendments to licence conditions and codes of practice (LCCP) for all operators.
 - Placing digital adverts responsibly (supplementary consultation)
 - Extending the requirement to assess and manage money laundering risk to nonremote lotteries (supplementary consultation)
 - <u>Controlling where gaming machines may be played in betting, bingo and casino</u>
 <u>premises</u>
 - High turnover bingo operators and multi-operator self-exclusion requirements.
- 2 LCCP July 2016 comes into force on **31 October 2016**.
- We publish the general licence conditions and codes of practice, which apply to licensed gambling operators, in the document entitled *Licence conditions and codes of practice* (LCCP), which is revised from time to time. We publish the current version of LCCP on our website and notify licensed operators. We also publish sector-specific extracts of LCCP which are also available on our website.
- 4 We strongly recommend that you read the relevant response document if you have not had time to do so already, or refer to it when considering the intention and effect of a particular amendment to LCCP. The tables overleaf provide an overview and brief explanation of the changes. They are not intended to be exhaustive, so please refer to LCCP or the response document if you have a specific query.
- 5 The tables at the end of this document show the amendments to:
 - licence conditions in the orange table,
 - social responsibility code provisions in the blue table, with shading,
 - ordinary code provisions in the blue table with no shading. These set out good practice which operators should follow or demonstrate that an alternative approach is reasonable in the operator's particular circumstances; or that to take an alternative approach would be acting in a similarly effective manner.

Amendments to code provisions

LCCP contains two types of code provision:

- social responsibility code provisions: compliance with these is a condition of licences. Changes to social responsibility code provisions are shown in the table below in blue shaded rows.
- ordinary code provisions: operators may adopt alternative approaches to those set out in ordinary code provisions if they have actively taken
 account of the ordinary code provision and can demonstrate that an alternative approach is reasonable in the operator's particular circumstances;
 or that to take an alternative approach would be acting in a similarly effective manner.
