## Response

I write further to your request for information, below. Once again, please accept my apologies for the delay in responding.

Our electronic records for scratchcards start in 2004. Please find attached a spreadsheet which contains the information we hold. There are some gaps in the recorded information which is taken from a number of manually created spreadsheets.

With regard to your specific questions:

- 1. The overall odds of winning a prize on Game 401 we do not hold this information
- 2. The release date of Game 541 26 September 2011
- 3. The release date of Game 546 27 April 2012
- 4. The release date of Game 586 14 April 2014
- 5. The release date of Game 614 31 March 2014

The records from 2002 – 2004 are paper based records, where a file was created for each game. There are potentially around 200 separate files that are archived for these games and to extract the information would be a manual process which we estimate would exceed the time limit for processing a request.

Section 12 of the Freedom of Information Act 2000 (FOIA) makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit, which for public authorities, such as the Commission, is set at £450. This represents the estimated cost of one person spending 2.5 working days in determining whether the department holds the information, locating, retrieving and extracting the information. We estimate that it would take well in excess of 2.5 working days to determine appropriate material and locate, retrieve and extract these figures (where held). Therefore, this part of your request will not be processed further.

I hope you find this information useful.
