Weber-Stephen Products LLC AKA Weber, at 1415 S. Roselle Road, Palatine, Illinois 60067, will be acting only as a prize provider.

This Sweepstakes is NOT sponsored, endorsed, or administered by, or associated with Instagram or any other social media platforms where the Sweepstakes will be advertised. You understand that you are providing your information to Sponsors and not to Instagram or any other social media platform. - c. Sign up for Tillamook County Creamery Association's email list, Weber-Stephen Products LLC AKA Weber's email list, <u>and</u> Gaby Dalkin's email list. You may unsubscribe from each email list at any time in the future by following the unsubscribe instructions in each future marketing email. If you want to unsubscribe from all three email lists, you must unsubscribe from each one separately.

## Limit: one (1) entry per person and per Instagram account.

An Instagram account is required to enter and is available for free at <a href="http://instagram.com">http://instagram.com</a>. You acknowledge that there are specific Instagram terms and conditions that apply to your Instagram account. An entrant can only use one (1) personal and publicly viewable Instagram account to enter. Each entrant will be the authorized Instagram account holder at the time of Entry. The potential winner may be required to show proof of being the authorized account holder.

All entries received after the end of the Sweepstakes Period will be void and will not be eligible to win.

AND THE LAWS OF THE STATE OF OREGON WILL GOVERN THIS SWEEPSTAKES. EACH ENTRANT WAIVES ANY AND ALL OBJECTIONS TO JURISDICTION AND VENUE IN THOSE COURTS AND HEREBY SUBMITS TO THE EXCLUSIVE JURISDICTION AND VENUE OF THOSE OREGON COURTS.
